Authorization Engagement of Professional Services Miron Technologies, Inc., in the amount of \$2,459.56 in order to provide quarterly provision of 5 radiation monitoring badges and one control badge for use by Health Bureau Sanitarians performing lead paint inspections for child lead poisoning investigations. This is an informal quote and is below purchasing requirements, therefore only one (1) quote is necessary.

WHEREAS, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

The lead paint analyzer utilizes a radioactive source and monitoring badges are federally mandated for each user.
