AN ORDINANCE

Amending the Codified Ordinances, Part Two, General Legislation/Fees; Article Seven, Billing for Emergency Medical Services; Section 270-53 (B) Ambulance Service, by increasing the Special Event stand-by per hour fee (includes 2 Paramedics and 1 ambulance) from \$100 to \$160; and establishing a Special Event stand-by (per hour) for 1 Paramedic and 1 ambulance) at \$96.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That Section 270-53 (B) Ambulance Service shall be amended to read as follows:

The billing department will encode the charges as established below based on level of service provided, or by the patient's reported condition at the time of the dispatch:

Summary and Facts of the Bill

This Bill seeks to update the amount charged for Ambulance Stand-By rate which is charged during special events.

The current City ordinance charging \$100.00 an hour for an EMS crew does not meet our costs, and at times isn't appropriate for a standby service. Events of mass gathering or that are dangerous in nature generally require an EMS unit stand by for potential medical issues at the event. This can be a football game for the school district or college, or a street festival, fair, or 5k run/walk. When the event plan requires EMS, we currently charge \$100.00 per hour of coverage. While most events just have one ambulance with two paramedics on board, we still lose money covering the event.

As of today, based on the average top step hourly rate for paramedics and the cost of benefits and insurance, it is roughly \$64.00 an hour per person to staff the event. That's \$128.00 per hour for an ambulance crew to attend. This doesn't include fuel, wear and tear, etc. on the vehicle(s) present which is an additional cost of \$32 per hour.

The suggestion is to raise the cost to \$160.00 an hour for an EMS crew to provide coverage at a standby event. If for some reason the event requires a single provider, \$96.00 per hour is appropriate, but these should be rare. I would also like the verbiage to include potential additions for extra crews as deemed appropriate by the special events coordinator. Historically, we don't charge for city sanctioned special events. But when we provide service to private events, we need to meet our costs.

Increasing the standby rate charged for events will more appropriately cover our costs and increase revenue for the City.
