AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a deposit of One Thousand Two Hundred and Sixty-Three Dollars and Seventy-Three Cents (\$1,263.73) of donation funds from Homebase Skate Shop to help contribute to the cost of construction for our Skatepark. These funds would be placed in the Jordan Skatepark capital project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2022 Capital Fund by donated amount from Homebase Skate Shop in the amount of One Thousand Two Hundred and Sixty-Three Dollars and Seventy-Three Cents (\$1,263.73):

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the Capital Fund to Jordan Skatepark Capital Project in the amount of One Thousand Two Hundred and Sixty-Three Dollars and Seventy-Three Cents (\$1,263.73) as follows:

SECTION TWO: That this Ordinance takes effect ten (10) days after final passage.
