## Introduced by the Administration on February 15, 2023

Authorization for Contract with Ross Body & Frame Works, Inc. d/b/a A-1 Towing Service for a total estimated sum of \$10,000.00 per contract year to provide towing services for City Fleet vehicles to the City of Allentown. The City of Allentown currently operates a fleet of 620 vehicles and equipment. The fleet consists of sedans, trucks, street sweepers, fire trucks, heavy construction equipment, tractors, police cruisers, aerial lifts, scooters, turf mowers, sewer trucks, motorcycles, snow removal equipment, etc. This project was competitively bid, one (1) response was received.; the contract is for one (1) year, upon written consent the contract term may be extended for up to four (4) additional one (1) year terms.

**WHEREAS,** Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS,** it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

On December 22, 2022, the City advertised a solicitation for City Fleet Towing Services, the intention of this Invitation to Bid is to secure vendors to provide towing services for City Fleet vehicles to the City of Allentown. The City of Allentown currently operates a fleet of 620 vehicles and equipment. The fleet consists of sedans, trucks, street sweepers, fire trucks, heavy construction equipment, tractors, police cruisers, aerial lifts, scooters, turf mowers, sewer trucks, motorcycles, snow removal equipment, etc. The Contract term shall commence upon full execution and shall cease one (1) year thereafter. Upon written notification, this contract can be extended for an additional four (4) one (1) year terms beyond the contract expiration period. On January 23, 2023, there was a public opening held, one (1) bid was received. Upon review of the bid it was determined that Ross Body & Frame Works was the only bid and therefore at this time the City is recommending award to Ross Body & Frame Works.
