AN ORDINANCE

Amending the 2023 ARPA Fund by transferring One Hundred Thousand (\$100,000) Dollars from the ARPA Fund to the General Fund for the Credible Messenger program; and One Million Two Hundred Thousand (\$1,200,000) Dollars from the ARPA Fund to the Capital Fund for the Irving Pool Project.

The bill originates from the Administration and Council.

- **Summary and Facts of the Bill**

The bill provides \$1.2 in ARPA for Irving Pool bids – the city received three bids for the construction that were competitive – the proposed awarded bid is for 3.1M, 1.2M above the initial projected cost. When initially bid the first time, the city received no bids. In 2020, the city started the process for a design consultant on Irving Pool – the consultant and city are still trying to adjust to a new environment that entails increased costs for labor and material.

The \$100,000 set aside is to develop an RFP for a consultant to design a strategy and evaluate a pilot program relating to anti-violence, a credible messenger, interrupter or similar program subject to the design and responses to an RFP.
