



PROJECT NARRATIVE

The project site is an 8,800 sq.ft. partially open lot at 2955 Ithaca Street in the City of Allentown. This lot was the remnant of the City of Allentown parks property and fill material has been placed on the lot over many of years. This lot is surrounded by townhouses, apartments and single residential building. The entire area is fully developed.

This project proposes to construct a one twin-family dwelling which will be constructed in the front portion of the lot.

The 800 GPD (2 EDU @ 400 GPD). The type of connection for this project is a tap-in to an existing sewer line in Ithaca Street, which flows into the Jordan Creek Interceptor collection system which ultimately is conveyed to the City of Allentown Kline's Island WWTP.

Alternatives Analysis:

The proposed method of sewage disposal for the tap-in at 2955 Ithaca Street with flows equating 800 gallons per day is via connection to the public sanitary sewer. The project will discharge into the flows into Jordan Creek Interceptor then to the City of Allentown's Klines Island Wastewater Treatment Plant.




Project Boundary
