AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a transfer of One Hundred Ten Thousand (\$110,000.00) Dollars from Capital Account Traffic Signals-Upgrade Various (1225) to a newly created Capital Account for the match money needed to install the traffic adaptive system on Hanover Avenue from Albert Street to Wahneta Street.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer of One Hundred Ten Thousand (\$110,000.00) Dollars in the following manner:

- What department or bureau is this bill originating from? Where did the initiative for the bill originate?

Department of Public Works – Traffic Planning & Control

- Summary and facts of the bill.

The Bureau of Traffic has applied and been awarded a MTF-DCED Grant to install the traffic adaptive system on Hanover Avenue from Albert Street to Wahneta Street. This grant also includes installing a Rectangular Rapid Flashing Beacon flasher at Hanover Avenue and Linden Street. To be transparent and clean a transfer of \$110,000 is needed from Capital Account Traffic Signals-Upgrade Various (1225) to a newly created Capital Account for the match money needed specifically for this project. The name should be “Hanover Ave Traffic Signal Improvements”.

 - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

The purpose of this resolution is to transfer \$110,000 from a general Capital Account to a newly created Capital Account to cover the match funds needed for this grant. The match funds will cover the design engineering of this project.

The benefit of doing this resolution is to transfer the funds needed to cover the match money needed for this grant. The City applied and was awarded the grant for \$1,260,000 of which \$110,000 is City match.

- c. How does this bill relate to the City's vision/mission/priorities?

The purpose of this ordinance is to install traffic adaptive system on Hanover Ave from Albert Street to Wahneta Street and install a new Rectangular Rapid Flashing Beacon flasher at Hanover Avenue and Linden Street.

Total cost is \$110,000 to cover the match money needed for this grant that has been awarded to the City.
