AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a total transfer of Five Thousand Five Hundred Ninety-Seven Dollars and Fifteen Cents (\$5,597.15) among Capital Projects with the final outcome being the closure of Capital Project 2028 – Police Academy Road and Parking Lot and Capital Project 2209 Mack Pool. These Capital Projects are complete and have been reconciled by the Finance Department.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of Five Thousand Five Hundred Ninety-Seven Dollars and Fifteen Cents (\$5,597.15) Dollars as follows:
