Affordable Housing: Retain Civic Contribution of \$25,000 for My Brother's Keeper – deleting the \$299,999 transfer into a new enterprise fund for an affordable housing program, creating the fund with 1 - 1 further funds contingent upon submittal of a plan. MacLean, Zucal – (7-0)

Delete position of Emergency Management Coordinator – Zucal, MacLean – (Failed, 2-7; Zucal, MacLean)

Delete Position of Human Relations Officer in the CED budget and allocate \$25,000 in temporary wages for part time staff person - Guridy, Zucal – Sponsorship pulled

Delete Financial Analyst position proposed at a new grade in the Budget – Zucal, Guridy – Sponsorship pulled)
