Introduced by the Administration on July 20, 2022

Authorizes Revisions to the Pennsylvania Department of Transportation Multimodal Fund Grant Reimbursement Agreement for Highway and Bridge Projects (No. 057444C)

Resolved by the Council of the City of Allentown, That

WHEREAS, that the City of Allentown, Lehigh County entered in agreement with the Commonwealth of Pennsylvania, Department of Transportation on May 25, 2017 for safety and operational improvements in downtown Allentown (PennDOT Contract No. 057444C).

WHEREAS, PennDOT Contract No. 057444C has been amended previously in 2019 and 2021 via Letters of Amendment.

WHEREAS, the City of Allentown and PennDOT request to amend Contract No. 057444C) a third time to further amend the terms of the Original Agreement, update the Project scope and exhibits to include a traffic responsive signal system and GPS at 56 intersections.

WHEREAS, the amount of PennDOT Contract No. 057444C remains as originally awarded in the amount of Two Million Seventy Thousand Dollars (\$2,070,000).

WHEREAS, that the City of Allentown hereby designates Matt Tuerk, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to revise PennDOT agreement for Two Million Seventy Thousand Dollars (\$2,070,000) in Multimodal Transportation Funds to the Department of Transportation.

The original scope of work for the Multimodal Grant submission was for traffic signal improvements at 56 intersection and widening of Lehigh and Union Street with a new traffic signal but the cost came in much higher than anticipated. PennDOT changed the original scope of work to remove the intersection widening at Lehigh and Union Street with a new traffic signal and has updated the scope of work to improve 56 intersections, which is 36 intersections with GPS preemption and 20 intersections with Traffic Adaptive System and GPS preemption.

In addition, the signatory page needs to be updated with the new Mayor and the new Finance Director.
