AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for an appropriation of the donation of Twenty Thousand (\$20,000.00) Dollars from Friends of the Allentown Parks into the Bogert's Bridge capital project account. These funds will be used for design and construction of Bogert's Bridge.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2022 Capital Fund in the amount of Twenty Thousand (\$20,000) Dollars from the Friends of Allentown Parks:
