AN ORDINANCE

Amending the 2016 General Fund Budget to provide for a supplemental appropriation of \$116,087.00 from a FEMA US Department of Homeland Security Assistance to Firefighters Grant, to the Allentown Fire Department to provide for Wellness and Fitness equipment and health programs/training.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2016 General Fund in the amount of \$116,087.00 reflecting receipt of monies from a FEMA, US Department of Homeland Security Assistance to Firefighters grant to purchase and provide for Wellness and Fitness equipment and health programs/training.

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund to the Fire Department contract services program as follows:

SECTION THREE: That this Ordinance will take effect ten (10) days after final passage.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

Allentown Fire Department

- **Summary and Facts of the Bill**

The Allentown Fire Department was awarded a FEMA grant to purchase Wellness and Fitness Equipment and Health Program Training.

The Bill will provide funding for the purchase of Wellness and Fitness equipment and Health Programs. This funding will bring the Allentown Fire Department in compliance with NFPA 1983 standards for Health related fitness programs for Fire Fighters. It establishes the minimum requirements for a health-related fitness program for fire department members who are involved in rescue, fire suppression, First-responders, hazardous materials operations, special operations and related activities.

In order to be fit for duty, firefighters have to be physically and psychologically prepared to endure the demands of this profession. This standard requires fire departments to establish a "health-related fitness program that enables members to develop and maintain a level of health and fitness to safely perform their assigned functions."

The benefit of this new equipment is enormous to strengthen the members of the Allentown Fire Department so their mental, physical, and emotional capabilities are resilient to withstand the demands of emergency service response and better response to the City's needs.

This Bill relates to the City's vision and mission to provide a safe City for all who live, work and visit the City of Allentown. It has always been the City of Allentown's priority, as well as every elected official to provide safe and efficient Public Safety services to ensure a safe environment.

90% grant funded and 10% city shared budgeted expense.

The Wellness and Fitness equipment will comply with the NFPA 1983 standards currently in place on Health-Related Fitness Programs for Fire Fighters.

A FEMA grant is the funding source.

Grant deadline for monies to be spent will be ending June 2016.
