#### RESOLUTION

R123 - 2022

# Introduced by the Administration on August 17, 2022

Authorizes an update in the agreement between Carfax and the Allentown Police Department to enable the department to sell accident reports electronically through linking Carfax's website to the Department's website.

## Resolved by the Council of the City of Allentown, That

**WHEREAS,** Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, Article 130.17 of the Administrative Code provides "City Council must approve, by Resolution, all contracts for service, to do work or provide City services, which is currently being performed or provided for by City workers as of the effective date of this Ordinance except for temporary emergency service assistance of a duration not to exceed one week."

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement/engage services of the following names contractor/consultant, for the use and purpose indicated.

- 1. Name of Contractor/Consultant: Carfax
- Description of Service(s) to be provided: Provide copies of accident reports via Carfax's online portal at no additional cost beyond the \$15.00 the Police Department charges

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby authorizes the Mayor and/or such other City officials as deemed appropriate by the City Solicitor, to sign and execute a Contract or Amendment and such other agreements and documents as are deemed by the City Solicitor to be necessary and/or related thereto, with the above named contractor/consultant, for the project identified.

The Police Department wishes to enter into an updated agreement with Carfax for Police to enable the Department to sell accident reports electronically through linking Carfax's website to the Police Department's website at no additional cost to the public.
