Authorization for Contract with Flyway Excavating, Inc. in the amount of \$1,798,365.00 for the Valania Park, two bids.

**WHEREAS**, Article 130.16 of the City's Administrative Code requires City Council approval by Resolution for the award of contracts or engagement of professional services.

**WHEREAS**, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Flyway Excavating, Inc.
2. Project or Contract Reference: Bid 2022-04- Valania Park Improvement Project
3. Description of Service(s): The redevelopment of the park will provide public improvements which is inclusive, but not limited to a redesigned basketball court area, installation of permanent restroom facilities and spray park feature, creation of additional greenspaces, improved drainage, based upon stormwater best management practices, improvements to the pedestrian path and sidewalk, as well as improved lighting, surfacing, goals and seating.

- Description of project or scope of services to be provided:

On December 20, 2021, the City advertised a solicitation seeking to obtain a Contractor to provide construction services relevant to the redevelopment of Valania Park, which is approximately 1.3 acres. The redevelopment of the park will provide public improvements which is inclusive, but not limited to a redesigned basketball court area, installation of permanent restroom facilities and spray park feature, creation of additional greenspaces, improved drainage, based upon stormwater best management practices, improvements to the pedestrian path and sidewalk, as well as improved lighting, surfacing, goals and seating. On January 24, 2022, the City held the public opening, it received two (2) bids. Upon review it was decided to award to the lowest bidder, Flyway Excavating, Inc.

The Contract term shall commence upon full execution and shall cease one (1) year thereafter.
