This vendor performs weight scale inspections and quarterly service for the scale located at our Recycling Transfer Facility.

This vendor charges \$379.00 per quarterly service. A total of \$3,500.00 was budgeted in 2018 for this service.

 Maximum dollar value of all renewals provided for beyond the original term as if all renewals were exercised:

\$3,500.00 was budgeted in 2018.

• Reasons for recommendation of Administration and Council approval of contract:

City vehicles loaded with recyclable materials and yard waste must be weighed prior to leaving the Recycling Transfer Facility to assure they meet PennDOT requirements for CDL vehicles. Additionally, the City's contracted hauler weighs their vehicles before and after off-loading materials at the City's site to determine the weight of the dropped of material.
