**Resolved by the Council of the City of Allentown, That**



## Legislative Template

- **What department or bureau is this bill originating from?**

This bill originates from the Department of Community and Economic Development Grants Department on behalf of Phoebe Ministries.

- **Summary and facts of the bill.**

Phoebe Ministries is submitting a formal application to the Pennsylvania Office of the Budget (OB) for \$1,121,000 for Redevelopment Assistance Capital Program (RACP) funds that will support Phase II of the Phoebe Allentown Campus Revitalization project.

- **Purpose – Please include the following in your explanation:**

- a. **What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?**

The Resolution is a requirement of the application to demonstrate the City's support for the project and to designate Mayor Matthew Tuerk as the signatory of the contract with the Commonwealth of Pennsylvania.

- b. **What are the benefits of doing this? What are the drawbacks?**

The benefits of the project will be realized by senior residents of Allentown and their families.

- c. **How does this bill relate to the City's vision/mission/priorities?**

Phase II of this project will focus on increased accessibility and safety for senior residents, especially those issues related to mobility challenges. The project is consistent with Vision 2030, the City's comprehensive plan and is in line with the priorities identified in the Welcome Home Allentown: Housing Needs Analysis and Strategic Plan.

- a. **Cost (initial and ongoing)**

The grant application is for \$1,121,000. Funding must be matched by the Subrecipient. All funding commitments are the responsibility of the Subgrantee and there is no financial impact or risk to the City.

The project will ensure safe, updated, and welcoming facilities that better serve residents and the community.
