Authorizes revisions to the Multimodal Transportation Fund DCED Grant Contract to update the signatories to the current Mayor and Finance Director. (PennDOT Contract No. C000076388)

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown, Lehigh County entered in agreement with the Commonwealth of Pennsylvania, Department of Transportation on July 2, 2021, for lighting upgrades on Mack Blvd from Emmaus Avenue to the Railroad underpass (PennDOT Contract No. C000076388).

WHEREAS, that the City of Allentown hereby designates Matt Tuerk, Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requesting grant.

NOW, THEREFORE, BE IT RESOLVED that the Allentown City Council, hereby authorizes the City of Allentown to revise PennDOT agreement for Six Hundred Fifty Thousand Dollars (\$650,000) in Multimodal Transportation Funds to the Department of Transportation.

BE IT ALSO RESOLVED that Mayor Matt Tuerk and Finance Director Bina Patel, of the City of Allentown be designated to execute all grant documents and agreements between the City of Allentown and Multimodal Transportation Funds to the Department of Transportation.

BE IT FINALLY RESOLVED, that the City Clerk is authorized to execute a certificate attesting to the adoption of this resolution and to furnish copies of the resolution to appropriate agencies.
