## Introduced by the Administration on November 17, 2021

Approves City's Application to the United State Department of Justice Edward Bryne Memorial Justice Assistance Grant (JAG) Program for a Grant of Forty-Five Thousand Seven Hundred Twenty-Three Dollars (\$45,723) that will be used for technological upgrades to the Police interrogation rooms.

## Resolved by the Council of the City of Allentown, That

**BE IT RESOLVED**, that the City of Allentown, Lehigh County hereby requested a FY2020 Edward Bryne Memorial Justice Assistance Grant of Forty-Five Thousand Seven Hundred Twenty-Three Dollars (\$45,723.00) from the United States Department of Justice in response to the local solicitation for jurisdictions. The City of Allentown Police Department has been allocated Forty-Five Thousand Seven Hundred Twenty-Three Dollars (\$45,723.00). The funding was approved to support technological upgrades to the Police interrogation rooms.

**BE IT FURTHER RESOLVED**, that the City of Allentown hereby designates the Mayor and Finance Director as the official(s) to execute all documents and agreements between the City of Allentown and the Department of Justice to facilitate and assist in obtaining the requested grant.

**NOW, THEREFORE, BE IT RESOLVED** that the Council of the City of Allentown, hereby approves of the Grant for Forty-Five Thousand Seven Hundred Twenty-Three Dollars (\$45,723.00) in Justice Assistance Grant program funds from the Department of Justice.
