AN ORDINANCE

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Fourteen Thousand Seven Hundred Twenty-Eight Dollars and Sixty-Nine Cents (\$14,728.69) from the Commonwealth of Pennsylvania Office of The State Fire Commissioner Grant, to the Allentown Fire Department for the purchase of high-quality particulate hoods.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 General Fund in the amount of Fourteen Thousand Seven Hundred Twenty-Eight Dollars and Sixty-Nine Cents (\$14,728.69) reflecting receipt of monies from the Commonwealth of Pennsylvania Office of The State Fire Commissioner grant for the purchase of high-quality particulate hoods.

The bill originated from the Allentown Fire Department. An award of new funds is being provided by the Pennsylvania Office of the State Fire Commissioner for the purchase of high-quality particulate hoods.

- **Summary and Facts of the Bill**

Amending the 2021 General Fund Budget to provide for a supplemental appropriation of Fourteen Thousand seven hundred and twenty-eight dollars and sixty-nine cents. (\$14,728.69) from the Commonwealth of Pennsylvania Office of The State Fire Commissioner Grant, to the Allentown Fire Department for the purchase of high-quality particulate hoods.
