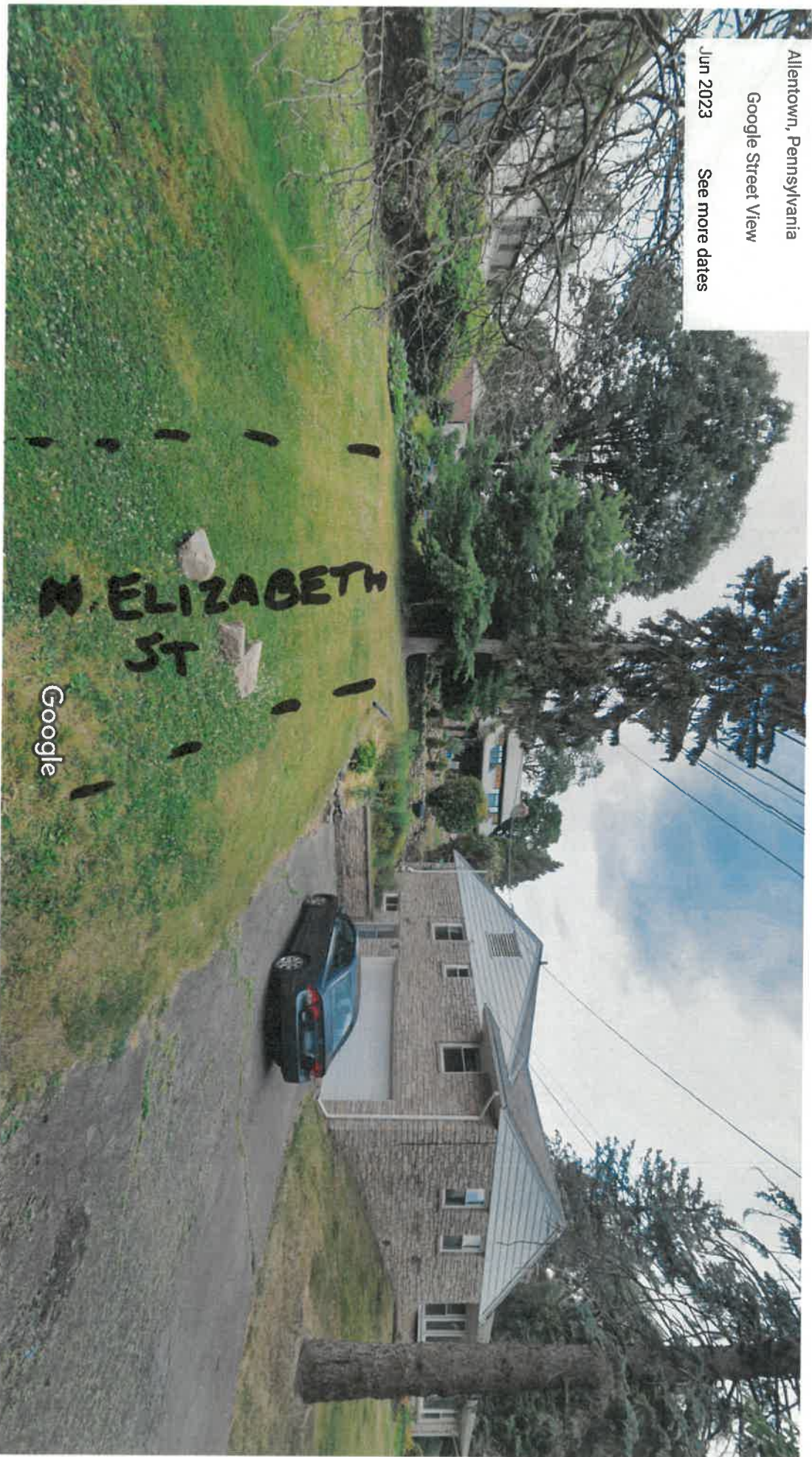

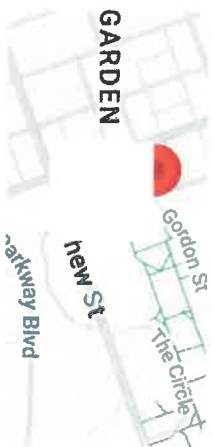

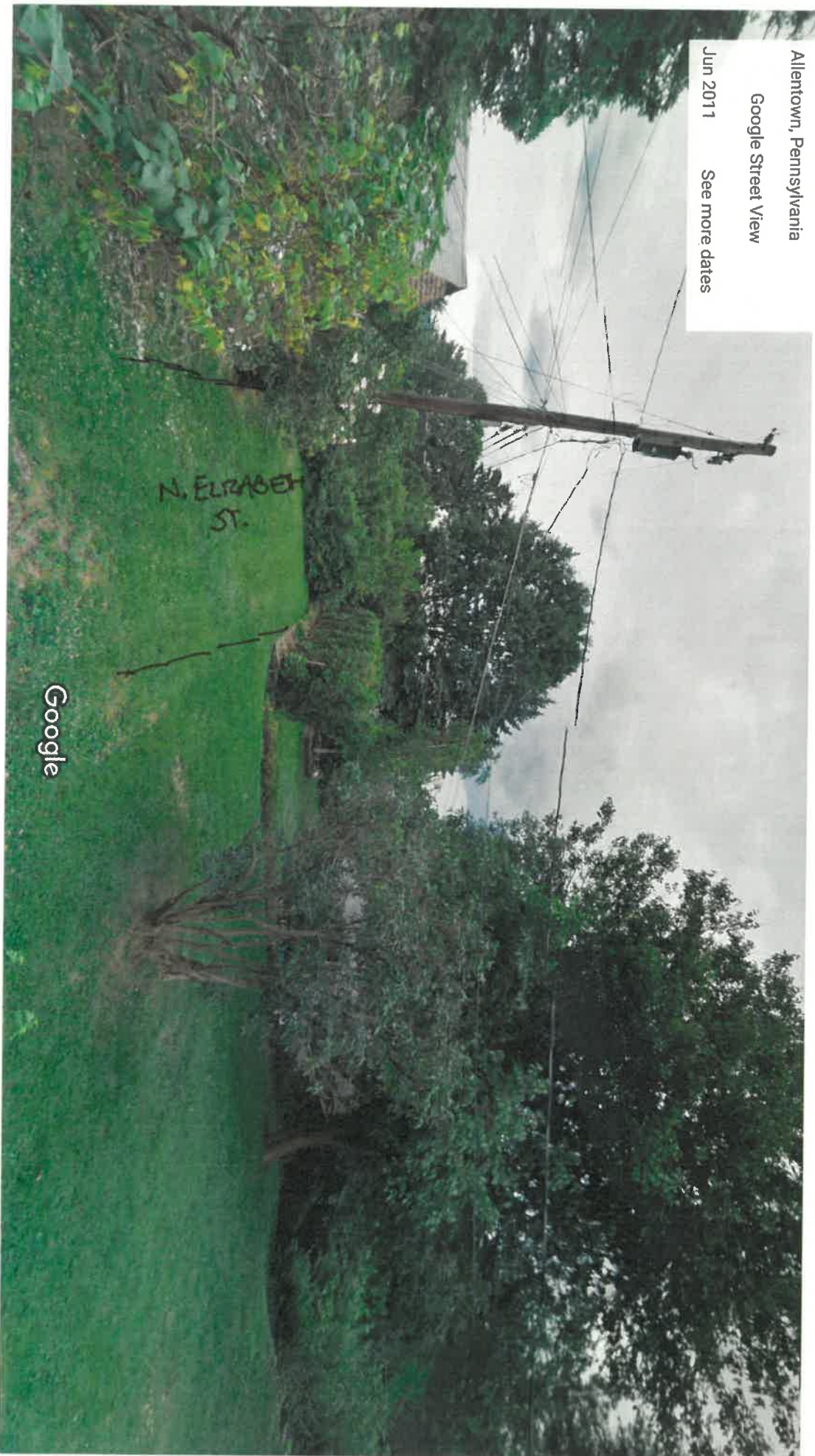

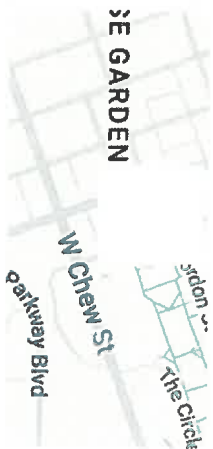

Proposed Street Vacation

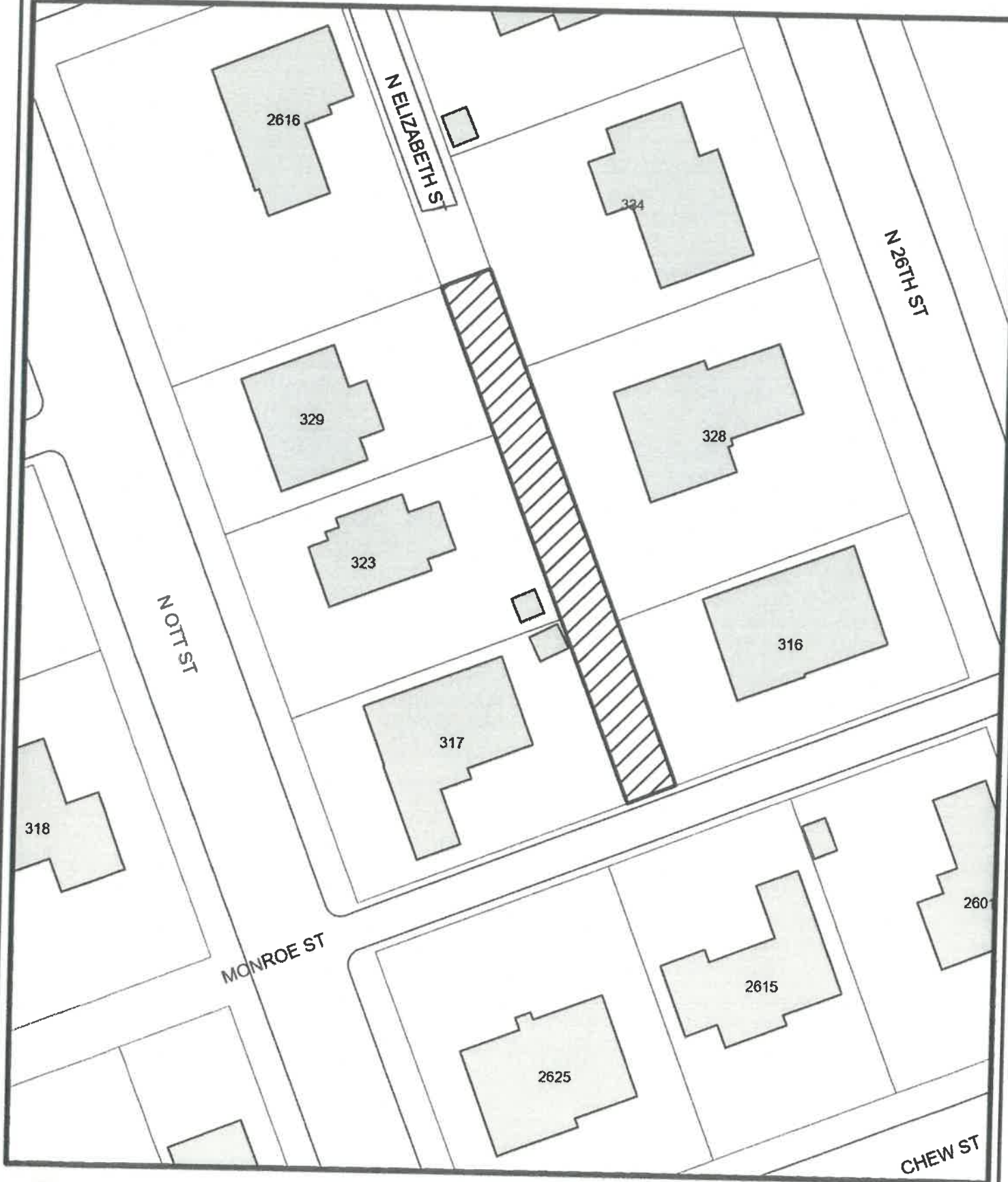


Proposed Street Vacation

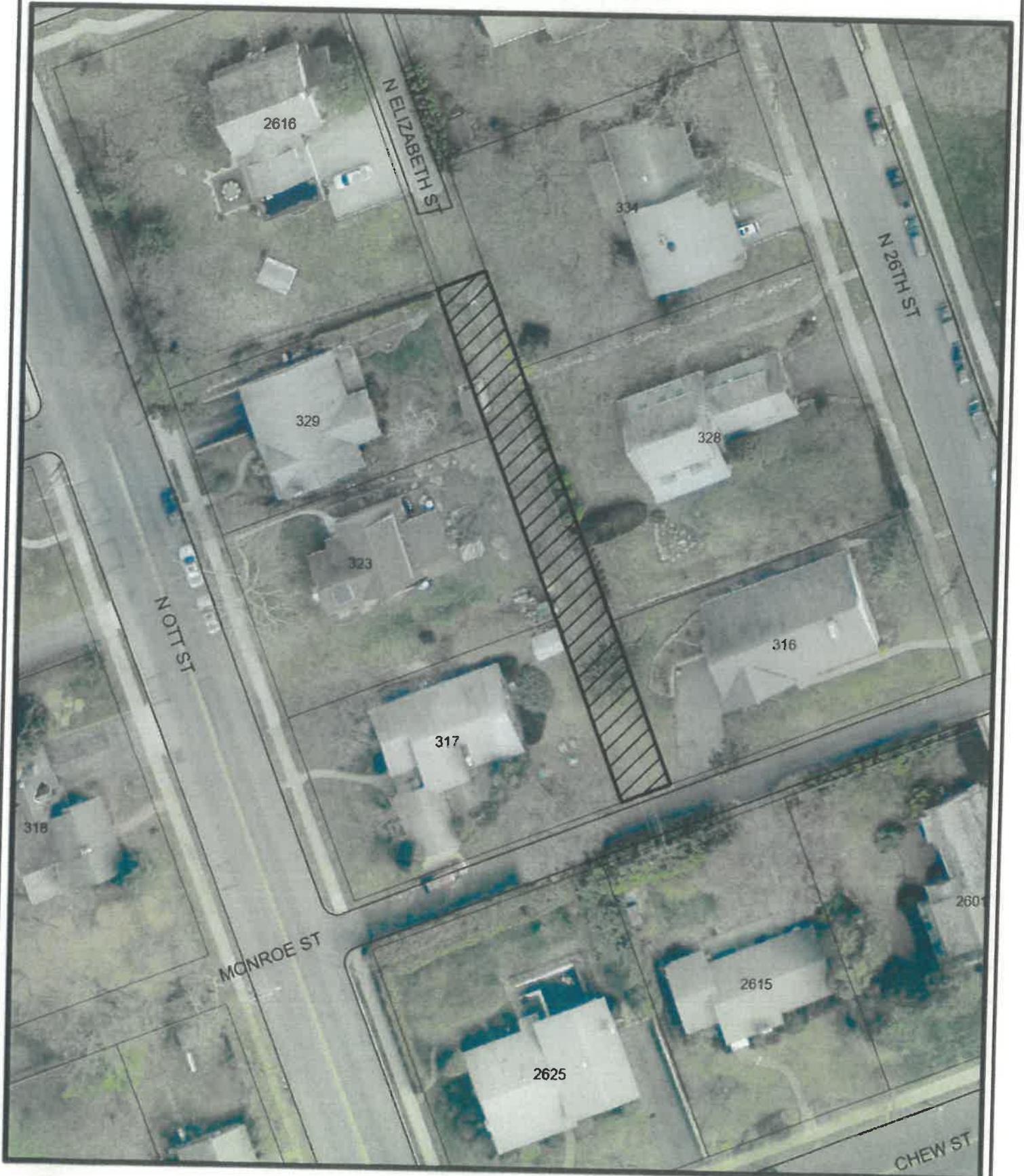


Proposed Street Vacation
