AN ORDINANCE

Amending the 2021 Golf Fund budget by transferring Seventy-Three Thousand Six Hundred Thirty-Two Dollars and Fifty-Two Cents (\$73,632.52) from the unappropriated balance of the Golf Fund to the Equipment Account for the purchase of a new rough mower.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council approves a supplemental appropriation from the unappropriated balance of the Golf Fund in the amount of Seventy-Three Thousand Six Hundred Thirty-Two Dollars and Fifty-Two Cents (\$73,632.52) as follows:
