Introduced by the Administration on September 3, 2025

Authorization for Contract with Bowman Consulting Group, Ltd. in the estimated amount of \$50,000.00 per year to provide technical assistance services to support the preparation and submission of grant applications under various Federal, State, and Local programs. These services will be used on an as-needed basis to support the City's efforts to secure funding for multimodal, safety, and infrastructure improvement projects. Five (5) proposals were received. Contract shall be for three (3) years with two (2) additional one (1) year renewal terms beyond the contract expiration period.

WHEREAS, Article 130.16 of the City's Administrative Code (recodified as §5-21) requires City Council approval by Resolution for the award of contracts or engagement of professional services.

WHEREAS, it is the desire of the City of Allentown to enter into an agreement with the aforementioned Contractor, for the use and purpose indicated in supporting the Recommendation of Award of Bid:

1. Name of Contractor/Consultant: Bowman Consulting Group, Ltd.
2. Project or Contract Reference: RFP No. 2025-30 Traffic Grant Assistance
3. Description of Service(s): To provide technical assistance services to support the preparation and submission of grant applications under various Federal, State, and Local programs. These services will be used on an as-needed basis to support the City's efforts to secure funding for multimodal, safety, and infrastructure improvement projects.

- Description of project or scope of services to be provided:

On June 26, 2025, the City advertised to solicit proposals from qualified engineering consulting firms to provide technical assistance services to support the preparation and submission of grant applications under various Federal, State, and Local programs. These services will be used on an as-needed basis to support the City's efforts to secure funding for multimodal, safety, and infrastructure improvement projects. On July 25, 2025, a public opening was held, for which five (5) proposals were received. The proposals were distributed to all committee members via Teams for evaluation. The Technical Evaluation was held on August 8, 2025, all committee members were present. The proposals were scored based on the following: IBE Preference (10 Points), Qualifications (30 Points), Experience (30 Points), and References (10 Points). The Cost Proposals were opened on August 8, 2025, and distributed to all committee members via Teams for evaluation after the Technical evaluation. The Cost evaluation was held on August 15, 2025, all committee members were present. The committee discussed the Cost proposals (30 Points). The evaluation committee decided not to hold oral interviews for this project. They have decided based on the Technical and Cost Proposal scores. The committee is recommending award to the top scoring firm, Bowman Consulting Group, Ltd.

- Contract Term:

The Contract term shall commence upon full execution and shall cease three (3) years thereafter.

- List any renewal term options and duration of each renewal, if any:

Upon written agreement, this contract may be extended for up to an additional two (2) one (1) year terms beyond the contract expiration period at the same annual terms of the initial term.
