## **Courtesy of the Floor**

Mr. Lou Hershman, 405 N. Gilmore Street, stated that Council should look to see if the City has a valid contract with LCA. Is the city of Allentown loaning employee to LCA when they are short on employees? He asked about the White Paper on the Golf Course.

Mr. Ray O'Connell stated Council will look into that.

Mr. Fran Dougherty stated that we are committed to doing that. He stated that he also saw the article in the Philadelphia Enquirer on the Reverse Options. This is the first time I am hearing about any loaning of personnel. There are MOU's governing what work we do for LCA and vice versa. Cynthia is going to hold a Special Meeting on the Golf Course.

Ms. Cynthia Mota stated April 6th.

Ms. Janet Keshl stated that Allentown is really bad with litter. She stated a long time ago the inmates would clean the litter.

Mr. Ray O'Connell stated that Mr. Ringer has brought that up numerous of times. It is a very good idea. It is a county prison.

Mr. Kenneth Heffentrager, 733 N. 11th Street - Allentown Tenant Association, stated 637 W Washington Street is still an unsecured building. Also, 521 W. Washington Street is another blighted property. It is full of garbage. At 105 N. 13th Street, the garage is wide open with garbage. He stated 418 W. Allen started coming down again. Why the sidewalk is not blocked from this property and 336 N. 12th Street is having these issues.

Mr. Dennis Pearson, 942 E. Tilghman Street, stated if you go across the street on S. Penn Street just before the administration building, post office and the hotel you will see a couple of plants there. There is a lot of garbage in that area. It is unsightly.

Mr. Ray O'Connell asked if it is private or public property.

Mr. Don Ringer, 1801 Liberty Street, stated that he wants to bring up the coordination between the city and the gas company and utilities. They decided to put a new gas main on Liberty Street at the busiest time of the year. We have spent over \$4 million in legal fees for the LCA Lease. He doesn't think that it includes the lawyer fees or the finders fees for that particular project. What we have gotten in return in higher water rates in Allentown.

The Committee has not met since the last meeting, a future meeting will be scheduled to deal with the two items on tonight's agenda that will be referred to committee.

#### MANAGING DIRECTOR'S REPORT: 911 Consolidation

Mr. Fran Dougherty thanked Mr. O'Connell and stated we have an extension MD Report tonight. Michael Hilbert and Jonathan Hanson of MCM Consulting and they are here to give an update on the 911 Consolidation Study.

Mr. Michael Hilbert stated that we were legislatively mandated to look at consolidating our 911 facilities either with a consolidated manner with

Lehigh County or a Regional Manner with both Northampton and the City of Bethlehem. The city and the two counties and the City of Bethlehem gauged the service of MCM Consulting to look at the possibilities in this endeavor. The Report has been finalized. This will be a high level executive overview.

Mr. Jonathan Hanson stated that he appreciates the opportunity to speak on the report. The cities were advised unofficially that they would not receive 911 funding when the Chapter 53 of Title 35 sunsets on June 30, 2019. He discussed the Report and developing a project team and establishing definitions. They did a review and analysis. They looked at budgeting and staffing. The call volumes that Allentown takes in comparison to the other three calls and dispatches. Allentown takes more 911 calls then Lehigh County, currently. The current level of service has to maintain or have an improved level. There needs to be cost savings and job security. Would it be consolidation or regionalization? It needs to be a comprehensive plan and a consolidated process. They would see a salary savings of about \$140,000 per year from the 911 fund, not from the city. They don't see any telecommunicators would lose their job if that is the decision that is made. It would be a potential cost savings of their salaries of \$322,000. Equipment cost savings in Allentown if the city would consolidate with the county those costs would be split or borne by the county. The maintenance cost savings could be up to \$135,000 per year. Lehigh County does not have a union representation with their employees. We would expect that their will be some contract negotiations that would be needed there. Lehigh County has the space to take the city, but that is about it. It would be maxed out at that point. Northampton County has room at their facility. They have several hundred acres and has plans to expand their facility. Based on the first quarters payments we would project that you will get about \$2.6 million this year.

Mr. Ray O'Connell stated that we got the best 911 in the state of Pennsylvania. He asked the difference between regionalization and consolidation. What does Easton do? What does it mean for the city employees?

Mr. Jonathon Hanson stated that consolidation will be the cities going together with the counties. He stated that he can't address the city employees. He discussed the oversight board that will have representation from all entities.

Mr. Michael Hilbert stated that Easton is with Northampton County. That would simple be part of the process of the city and the counties.

Mr. Daryl Hendricks asked about the costs and stated what if there are no

cost savings realized. How would the costs be respected to each municipality.

Mr. Jonathon Hanson stated that he does not know how cost would be increased because you will not be providing the services or the employees. The oversight board would have to work it out with PEMA.

Mr. Julio Guridy asked about the consolidation. Initially, it could be that Allentown consolidates with the Lehigh County. Bethlehem would consolidate with Northampton County. We have three years to do this. He asked what would be the advantage to consolidate with Lehigh County.

Mr. Jonathon Hanson stated that is his understanding unofficially when the funding would stop. We found that you will have the largest cost savings across all four if their is a regionalization. We don't think a regional facility can be built, staffed, and become operational within the three year timeframe.

Mr. Michael Hilbert stated that the Northampton County facility is a separate facility at Gracedale. it is a separate building next to the parking lot at Gracedale. It is simply a point of reference.

Mr. Roger MacLean asked about the \$500,000 that won't be coming out of the General Fund anymore. Did we take into consideration what it is going to maintain this dispatching for streets. He asked about the rationalization of the consolidation and the regionalization.

Mr. Jonathan Hanson stated that we are recommending that all ancillary services continue even at the consolidated structure. No, none that was directly mentioned. He thinks that there is a concern of losing autonomy at the part of the county.

Mr. Michael Hilbert stated that the city is in the process of doing that. When the discussion starts with Lehigh County, we need to know what they are going to take and what they are not going to take.

Mr. Ray O'Connell asked any other comments from my colleagues.

Mr. Julio Guridy asked about the county regionalization. He is concerned about what Mr. O'Connell mentioned on how well we know our streets and our city.

Mr. Jonathon Hanson stated that there are PSAPS in place. In Alleghany County, their dispatchers in the city of Pittsburgh only works in the city of Pittsburgh. They will take calls for the whole county. They have also split

the county into North County and South County.

Mr. Ray O'Connell stated that it started from Alleghany County. We are on first base. Is there anyone in the state on third base? Have they done this already or have they started this already?

Mr. Michael Hilbert stated that Alleghany was probably if you think back when this legislation was started in 1992. There were very few cities that were grandfathered under this. Philadelphia aside, is a city and county region. Pittsburgh was on its own. The City of Allentown and the City of Bethlehem. Pittsburgh merged with Alleghany in 1996 or 1997.

Mr. Jonathon Hanson stated not with MCM. Previously working with MCM, I was Director of the State's 911 Bureau. the contract between Alleghany and Pittsburgh was only put in the Report as a reference source.

Mr. Daryl Hendricks asked what happens to the city's surveillance cameras. Do they remain in house or fall in the auspicious of the PSAPS?

Mr. Michael Hilbert stated that is one of the questions. The Report recommends that the monitoring of that system be done at the PSAP level.

Mr. Roger MacLean stated that we are going to consolidate with the county and then regionalize. Who pays for all that? Is that coming out of the 911 Funds?

Mr. Jonathon Hanson stated that they have not released the guidance for application and use of those funds. There is a statewide advisory board meeting next week. it is on the agenda to be discussed.

Mr. Michael Hilbert stated that the new legislation has in it that 15 percent of the total revenue all now goes to the state and is earmarked for this interconnectivity and regionalization effort. It is that pool of money is where these efforts would have to come from. The City of Allentown has been in this business since 1973. Twenty years before this legislation was first adopted that funded all of this.

Mr. David McGuire stated that this could be a two step process. Allentown, plus Lehigh County becomes one unit and sometime in the future there is an equivalent of Bethlehem and Northampton.

Mr. Michael Hilbert stated that is the recommendation.

Mr. Ray O'Connell asked any comments or questions from my colleague or the public.

Mr. Danny Warg stated that he is concerned about the level of safety for the police officers and the citizens. The merger of these systems is paramount.

Mr. Ray O'Connell stated that was one of his original questions. He totally agrees.

Mr. Roger MacLean stated that Pittsburgh dispatchers dispatch to Pittsburgh so they can keep their institutional knowledge. How do that?

Mr. Jonathan Hanson stated that it is like bringing a new dispatcher here into the city. You train them and they learn over time.

Mr. Michael Hilbert stated that Berks County does a similar operation where traditional in the City of Allentown rotates all positions. We have to know how to do police, fire, ems, cameras, the Parking Authority. In larger centers, you are basically hired as a call taker.

Mr. Daryl Hendricks stated that he would be remised if he did not offer his sincere appreciation to Mike Hilbert. Mike is one of the most valuable and dedicated employees in Allentown. he just completed 35 years of service, and I had the pleasure working with him during the entire period. We are losing an extremely talented and dedicated employee.

Mr. Julio Guridy stated that goes from all of us. I worked with you on several occasions, Mike and you were always well-versed on issues.

Mr. Roger MacLean stated that we went through this and back in 2006. I know I spoke to several Chiefs in the state of Pennsylvania who was a part of a consolidated or regional dispatching system, and the last one I spoke to, they wish they could revert it back.

Mr. Ray O'Connell stated to Mr. Hilbert that this is our last City Council meeting.

Mr. Fran Dougherty stated that this is the start of many conversations concerning this consolidation and long-term regionalization, Phase I and Phase II. This comes at a time when we are losing our superstar. This is absolutely critical that it is done right.
