AN ORDINANCE

Amending the 2024 General Fund Budget to provide for a supplemental appropriation of One Million One Hundred Eighty-Three Thousand Fifty-Four Dollars (\$1,183,054.00) from the Pennsylvania Commission on Crime and Delinquency (PCCD) Grant to the City of Allentown Police Department. These funds will be utilized for reimbursement of expenses for the purchase of new city cameras, new in-car cameras for the entire police fleet and new body-worn cameras.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation of One Million One Hundred Eighty-Three Thousand Fifty-Four Dollars (\$1,183,054.00) to the following account:

- Summary and facts of the bill.

Purpose of the ordinance is to amend the 2024 General Fund Budget to provide a supplemental appropriation of One Million, One hundred eighty-three thousand, fifty-four \$ 1,183,054 from the Pennsylvania Commission on Crime and Delinquency (PCCD) Grant to the City of Allentown Police Department to utilize the funding for reimbursement of expenses for the purchase of new city cameras, new in-car cameras for the entire police fleet and new body worn cameras for the police department.

- Purpose – Please include the following in your explanation:
 - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

This is an allocation of \$ 2.63 million by Pennsylvania Commission on Crime and Delinquency (PCCD) Local Law Enforcement Grant Program. This budget is broken into a two-year period allowing for \$ 1,453,537 to be utilized in 2023 and the remainder budgeted of \$ 1,183,054 for 2024. The funding will allow for reimbursement of expenses for the purchase of new city cameras, new in car cameras for the entire police fleet and new body worn cameras for the police department.

- b. What are the benefits of doing this? What are the drawbacks?

The benefits to the use of the technology purchased through this grant will allow officers a technological advantage for years to come. The city will be outfitted with new cameras throughout the city that will not deter crime and traffic accidents but also provide evidentiary value for areas of the city in which there are no current cameras. The new in car and body worn cameras will ensure that incidents are documented as much as possible and will increase the transparency and visibility between officers and the public in which we serve. There are no considerable drawbacks to these requests.

- c. How does this bill relate to the City's vision/mission/priorities?

The city of Allentown is committed to drastically reducing crime and motor vehicle accidents with the deployment of new city cameras. The city of Allentown is committed to providing transparency and visibility with its officers and citizens. The use of these new technological items will aid in the resolution of crimes in 2024. The use of this grant to

reduce crime and traffic accidents while increasing transparency will fall directly in line with the priorities of the City of Allentown

- The grant for 2024 year is in the amount of \$ 1,183,054 based on expected expenses for purchasing the city-wide cameras, in car police cameras, and body worn cameras.

- The benefits will be substantial from the implementation of the grant. Officers will be able to gain evidence for the prosecution of crimes with the use of the new city cameras. Officers will have new state of the art cameras in their vehicles and on their persons to document details of incidents they are involved in. The use of the grant will substantially help in deterring violence and aiding officers with their investigations in the city of Allentown.
