R161 - 2025

Introduced by the Administration on November 5, 2025

Authorizes the submission of a Formal Application for the Local Share Account (LSA) Grant by the City of Allentown for funding from the Pennsylvania Department of Community and Economic Development Services in the amount of approximately Two Hundred Thousand Dollars (\$200,000) to conduct a feasibility study on converting select one-way streets into two-way streets.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of submitting a formal application to the Pennsylvania Department of Community and Economic Development to hire a consultant to complete a feasibility study to convert select one-way streets in the City to two-way streets.

WHEREAS, this feasibility study supports the Allentown Vision Zero and Safe Streets and Roads for All Safety Action plan to eliminate severe traffic injuries and fatalities. Investing in this study positions the City to make informed, cost-effective safety improvements that benefit residents, businesses, and visitors alike.

NOW, THEREFORE, BE IT RESOLVED, that the Allentown City Council, hereby authorizes the City of Allentown to submit the application for approximately Two Hundred Thousand Dollars (\$200,000) in the Pennsylvania Department of Community and Economic Development Services to the Commonwealth Financing Authority.

BE IT FURTHER RESOLVED that the City of Allentown hereby designates Matt Tuerk, Mayor, and Bina Patel, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth Financing Authority to facilitate and assist in obtaining the requesting grant.
