### Old Business

Ms. Ce Ce Gerlach stated that she has two items. The first item was at a previous Public Safety Committee Meeting, she brought forward a Resolution making body camera footage subject to Right to Know laws. It was the committee's recommendation that Jim Martin weigh. Has he weighed in yet? Has anyone asked him to weigh in yet?

Mr. Julio Guridy stated not to him.

Ms. Cynthia Mota stated that they have to get back to her on that one. Give them at least a week and see what he has to say.

Ms. Ce Ce Gerlach stated for awhile now they have been talkin about homelessness and encampments and clearing of encampments. She wants the system do its thing and play out. Prior to the Intergovernmental meeting she found out some information that is quite troubling and she cannot let the system playout and things to work out. The system is the problem. There are two unsheltered individuals that currently live underneath a bridge. They were living in tent city. It turns out that these two individuals must vacate the premises by tomorrow, the 17th. They were told on June 3. This property is owned by the county. the3re is one individual who made this declaration that these two individuals must vacate. These two individuals cause no issue. She asked for someone to challenge that. The Chief of Police Glenn Granitz and the Mayor knew the individual and his girlfriend was there.

Mr. Julio Guridy asked the Mayor to have a conversation and stated that this is the first time he has heard about this whole issue.

Mayor Ray O'Connell stated that he will call Mr. Armstrong tomorrow. The county need to step their game up. It should be brought to the Lehigh County Commissioners.

Mr. Julio Guridy asked Mayor O'Connell to keep Council abreast of what happens.

Ms. Ce Ce Gerlach stated that is has been. She found out from a Commissioner why this was happening.

Mr. Joshua Siegel stated that they are not going to name names. It is a person with significant power and influence within the cabinet of Lehigh County. That is creating an issue and we sit hear repeatedly over and over again and say the county has to be part of the solution, the county has to step up its game, the county has to be an active partner when there are people within the county who are in a position where they are expected to run the logistics in the county and are expected to be part of these decisions who use language that is obviously counterintuitive who is dehumanizing the very people we are trying to help. That is the issue. Someone has got to put their foot down. It is unacceptable. Get in or get out, if you are not going to get with the program. It needs to be impressed upon the Executive that sort of behavior coming from his cabinet is a fireable termination offense and has no business here. He stated to the Mayor that he would not accept it and we should not accept it.

Mr. Julio Guridy stated that the city set aside \$100,000 last year in the budget to look into the homeless issue. The county set aside \$200,000. We should be able to do something.

Ms. Ce Ce Gerlach stated to keep in mind, they need to go by tomorrow.

Mr. Julio Guridy stated that the Mayor is calling Mr. Armstrong. The county has human services program with crisis intervention.

Mayor Ray O'Connell stated that he is going to call Mr. Armstrong tomorrow. He doesn't have the magic wand either.

Ms. Ce Ce Gerlach stated that it is not about crisis intervention. There are requirements for the shelters, they will not need the requirements.

Mr. Julio Guridy stated that the next thing is put them up in a hotel. The county has programs that they can work with.

Ms. Ce Ce Gerlach stated that is not the issue. They should not be made to leave.

### **Communications: DaVinci Update**

Ms. Lin Erickson - DaVinci Presentation that Council President Guridy, member of Council for the opportunity to meet with them and share their plans for the new Science Center and ask them to consider a portion of the American Rescue Plan Act (ARPA) funds to support the development of the Science Center. She thanked them all for the city's support. They would not have made the progress thus far without them. The total project is \$65 million. They have more than half of that committed to date from public and private donors. This will be the third largest science center in Pennsylvania once completed. They will break ground in March 2022. It is in the Neighborhood Improvement Zone in the heart of downtown. They selected this site specifically to increase access to STEAM education experiences for traditionally underserved audiences. There are 52,000 Allentown residents within one mile walking distance to the site. With 72 percent low to moderate income households. There are five public and six Charter Schools within the target benefit area. The second reason they like this site is that they can build on the development that is going on downtown Allentown by creating a major visitor destination. The DaVinci Center is requesting \$2 million in the American Rescue Plan Act funding from the City of Allentown to support the construction of the facility and exhibits.

Mr. Julio Guridy thanked Ms. Erickson and asked if there were any questions from Council.

Ms. Ce Ce Gerlach stated that it is great to hear that the DaVinci Center will hire local folks and making sure that the folks who are featured in the Center represents various backgrounds as do most folks in Allentown. For the time that she was on the School Board, she knows that DaVinci does a great job partnering with the School District. She knows that she and Ms. Erickson have spoke a year or two ago about this concept. This concept will soon be reality. The one slide had some itemized specific numbers. She was wondering how specific when it comes to employment of Allentown residents. What kind of plans or partnerships that you either exploring or have potentially an agreement.

Ms. Lin Erickson stated that she would like to say first as we are coming out of Covid in our current operation, they have a lot of positions open. They are reaching out within the community and need assistance from all of them because they don't want to wait until six months or a year before they open to be building a staff that has made a representative from downtown Allentown. They are interested in starting that now and expanding their ability to recruit more diverse candidates and Allentown residents. They talked about a STEM career ladder.

Ms. Ce Ce Gerlach stated about a month ago when they talked about DaVinci, Mr. Lightner was here and they had a brief conversation to ensure how the Center is accessible for everyone.

Ms. Lin Erickson stated that they have further work to do, but want to make sure that they can provide access to all the residents of the city regardless of their ability to pay. They want to work closely with the city administration, the community groups and the school district to ensure that the experience can be available for all residents.

Mr. Julio Guridy asked if there were any further comments or questions.

Mr. Joshua Siegel thanked Ms. Erickson for the presentation. They have their meeting scheduled for Friday. The \$333 million is basically your economic output and the 487 full-time jobs. He is assuming a multiplier affect to get to the 487. How many are being created at the Science Center. He asked the breakdown of the salary range. He briefly touched on the \$2 million request and clarified if she was making a corresponding request at the county. They received considerable Rescue Funds. The state has been an enormous supporter of this project as well. They received \$20 million from the Redevelopment Assistance Capital Program. Will there be a corresponding request from the county and the state so they all can leverage their existing assets to make this final push. He asked if she requested the same \$2 million from the county. Is there some

procurement plan for the Center?

Ms. Lin Erickson stated that they are using an In-Plan Model to create those numbers. At the Science Center itself, they are projecting 60 full-time equivalent positions. With many part-time and many full-time on top of the positions that they currently have. That is a growth. Some are from subcontractors that they will engage in the Science Center. They anticipate a catering operator and a retail operator that will manage a store and for profit entities. She stated yes. At the state level they are focusing their efforts on securing additional RACP funds. They don't want to divert attention. They receive already \$1 million and requested another \$7 million. They are working very closely across the House and Senate and in the Governor's office to secure additional state support. In terms of the county, they have made a request and she knows that they are considering support. She is waiting to hear a final official word. She stated yes. She suspects there are some vendors they are already using. She would like to start that again now and go through the major things they purchase now.

Mr. Joshua Siegel stated that the most important thing is to be transparent and forward thinking.

Ms. Cynthia Mota stated that this is really exciting to see this project coming to fruition especially in the heart of Allentown. She has met with Ms. Erickson a few months ago a few times with Dan Bosket, the Parent Network, and the Promise Neighborhoods of the Lehigh Valley. She knows how important it was for her and her staff to be able to get a lot of community support and find out what the community really wanted. A lot of your programming will be bilingual. Majority of the people are Spanish speaking. It is also exciting that a lot of Allentonians are going to be hired. She cannot wait for this to happen as soon as possible.

Ms. Ce Ce Gerlach stated that she is just now looking at it from this perspective. That's Linden Street right there.

Mr. Daryl Hendricks stated that is Eighth Street.

Mr. Julio Guridy stated that is Eighth and Hamilton Streets. This is some of the things that he has been thinking about. Having the information bilingually and taking to account the Hispanic Community is obviously one of his major issues in the city. People look for he and Ms. Mota to advocate for them on Council because of the language issue they call them. It will be a plus for the entire community. He stated that Council will take Ms. Erickson request into consideration and to have this project fully developed in the community.

REFERRED TO RULES, CHAMBERS, INTERGOVERNMENTAL  
RELATIONS AND STRATEGY COMMITTEE

Ms. Frances Fruhwirth stated that if it is referred to committee under the Municipalities Planning Code which this Rezoning Amendment originates from as governed by. If there are any substantial changes which the law says it is. It could mean many different things. The city needs to start over the entire process under the Municipalities Planning Code. By consensus there is an amendment to the amendment then the advertisement, the public hearing, the referral to the Planning Commission and the Lehigh Valley Planning Commission will have to happen all over again.

Mr. Julio Guridy thanked Ms. Fruhwirth for bringing that up. He stated that he was not aware of that. He suggested that they continue to do the same.

Mr. Joshua Siegel stated that it is only appropriate. It is going to require substantial changes. We heard from the community and they are very significant and reasonable concerns. If we are going to do it right, we have to go through the process that might take a little time, but that is the cost to get it right for the community.

Mr. Julio Guridy stated that he agrees with Mr. Siegel.

Ms. Cynthia Mota agrees, but when you talk about a little bit of time are you talking three months, four months or six months.

Mr. Julio Guridy stated that he is not sure how long it is going to take. Obviously, the process a little longer.

Mr. Michael Hanlon stated at least two months if you hurry.

Mr. Joshua Siegel stated that they will quickly to identify what the amendments would look like and try to get them quickly laid out to get the process started.

Ms. Candida Affa asked if they are operating.

Mr. Julio Guridy stated that they are operating. They are just not deep frying.

Ms. Cynthia Mota stated that they are not and they had to let go a lot of employees because of that. The interesting thing is we talk a lot about they buy a property, they should know. The reality is that the real estate agent just wants to sell. She asked if they as a body were aware of the frying rules.

Ms. Candida Affa stated that she agrees with Ms. Mota. They went through this with people not aware and they are in Old Allentown. We asked the realtors to let people know. This poor owner paid \$250,000. This has been a restaurant since the 50s. Having a woman that is a real estate agent saying we should know this. It is appropriate for them and their responsibility to let them know. They are afraid they are going to lose this sale.

Ms. Ce Ce Gerlach stated that she will wait. Hopefully, they will be communicating about this soon. She was just looking at the map and knows a lot of places that fry food.

Ms. Candida Affa stated that regarding the Residency Requirement question she meant to say that their children could be in a different school district. A senior or junior and they do not want to take them out of the school.

Mayor Ray O'Connell stated that they call it an exit year, fifth grade to sixth, eighth - ninth, and 12th to college. He wants to echo Ms. Gerlach's comments. You only hear the bad that is happening at ASD, not the good. Three weeks ago they had 33 students at Allen, Dieruff and Building 21 got a high school diploma and a two-year degree. They are good, solid, and talented kids in the school district.

Ms. Candida Affa stated that she remembers years ago there was a student and the only one in the entire Lehigh Valley that got a full scholarship to Harvard and graduated from Allen High School.

Mayor Ray O'Connell stated there was one student that went to Harvard and the twin girls went to Princeton and a student went to Yale.

Mr. Julio Guridy stated that he remembers Don Bernhard's daughter went to Princeton. He thanked Ms. Affa for clarifying that.
