## Introduced by City Council on December 18, 2024

A RESOLUTION OF CITY OF ALLENTOWN, COUNTY OF LEHIGH, COMMONWEALTH OF PENNSYLVANIA, APPROVING THE INTERMUNICIPAL TRANSFER OF LIQUOR LICENSE NUMBER R-15779 TO RADHE KRISHNA MART, INC., 1234 – 1246 LEHIGH STREET, ALLENTOWN, PA 18103

## Resolved by the Council of the City of Allentown, That

**WHEREAS**, Act 141 of 2000 ("the Act") authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the transfer of restaurant liquor licenses across municipal boundaries within the same county regardless of the quota limitations provided for in Section 461 of the Liquor Code if, as in the City of Allentown, sales of liquor and malt or brewed beverages are legal in the municipality receiving the license; and

WHEREAS, the Act requires the applicant to obtain from the receiving municipality a resolution approving the inter-municipal transfer of the liquor license prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a resolution by the receiving municipality, at least one hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding applicant's intent to transfer a liquor license into the receiving municipality; and

**WHEREAS,** an application for transfer filed under the Act must contain a copy of the resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

**WHEREAS**, Radhe Krishna Mart, Inc. proposes to, and will, utilize the Liquor License to allow for the sale of alcohol in accordance with the Code (the "Proposed Use").

**NOW, THEREFORE, BE IT RESOLVED,** that Radhe Krishna Mart, Inc. has requested approval of the Allentown City Council for the proposed transfer of Pennsylvania liquor license no. R-15779 (as indicated on the Intermunicipal Liquor Transfer Request Petition, R-15779 - the subject license was won at the PLCB license auction conducted in October 2024; Requested information is not available to successful bidder) within the City of Allentown to be located at Radhe Krishna Mart, Inc., 1234 – 1246 Lehigh Street, Allentown, PA 18103 with the understanding that said transfer must be approved at a later date by the Pennsylvania Liquor Control Board.

**BE IT FURTHER RESOLVED,** that the City of Allentown City Council has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer.

**BE IT FURTHER RESOLVED** that the City of Allentown approves, by adoption of this Resolution, the proposed intermunicipal transfer of restaurant liquor license no. E-1180 into the City of Allentown by City Center Hospitality Ten, LLC. and the Proposed Use.

**BE IT FURTHER RESOLVED** that transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.
