**WHEREAS**, it is the desire of the City of Allentown to increase the contractual sum of the previously awarded agreement with the following named contractor/consultant, for the use and purpose indicated in supporting the Recommendation of Award or Contract dated September 2, 2020:

Description of project or scope of services to be provided and why is an increase needed:

On June 15, 2020, City Council approved the award of this contract to Buell Kratzer Powell for the amount of \$82,928.00. On September 2, 2020, the City entered into a fully executed agreement with the Contractor for a twelve-month contract term that would expire on September 1, 2021. On or about July 13, 2021, both parties entered into the First Amendment to the Agreement in order to increase the contract sum by \$5,500.00, which did not require Council approval because the increase was not 10% above the original contract term. Additionally, the Contract term was extended, utilizing the first and

sole renewal term option, through September 1, 2022. At this time, the Contract sum needs to be increased again by \$9,887.50 due to additional work the Contractor provided in order to obtain the demolition permit for the LCCD, this work was not anticipated for this project.
