Authorizes Submission of a Formal Application to the Pennsylvania Office of the Budget for a Grant of One Million Dollars (\$1,000,000) to support the DaVinci Science Center Downtown Allentown Project.

Resolved by the Council of the City of Allentown, That


BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Redevelopment Assistance Capital Program grant of \$1,000,000 from the Pennsylvania Office of the Budget to fund the development of the DaVinci Science Center Downtown Allentown.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for One Million Dollars (\$1,000,000) in Redevelopment Assistance Capital Program funds to the Commonwealth of Pennsylvania Office of the Budget.
