AN ORDINANCE

Amending the 2022 Capital Fund Budget to provide for a transfer of Fifty Thousand (\$50,000.00) Dollars from General Fund – CED into the Parks Master Plan Capital Project that was allocated for the grant match for this project. These funds would be placed in the Parks Master Plan Capital Project.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a transfer in the following manner:

SECTION TWO: That City Council authorizes an increase in the unappropriated balance of the Capital Fund as follows:

SECTION THREE: That City Council authorizes a transfer of Fifty Thousand (\$50,000.00) Dollars to the Parks Master Plan in the following manner:

SECTION FOUR: That this Ordinance takes effect ten (10) days after final passage.
