Department of Community and Economic Development. This Bill is the result of the successful application and award of the Local Share Account (LSA) grant for the Allentown Patriots Athletic Association.

The Allentown Patriots Athletic Association submitted a formal application to the PA Department of Community and Economic Development (DCED), for which the City will serve as the Grantee. The \$26,703.00 awarded in LSA funds will be used to purchase new equipment that will maintain the athletic field.
