Ms. Jessica Ortiz, 523 Tilghman Street, stated that she is very excited. Chief Roca is here and doing amazing things for the community and connecting. As someone who works with youth, gang members and drug addiction he has been an asset. Is he being considered for a permanent position. How long will his interim position will be and was this a conversation willing to have? She stated that she lives in a very bad neighborhood and Chief Roca's leadership has tickled down into her community.

Mr. Julio Guridy stated that he will take it into consideration and will let her know soon.

Mr. Thomas Houck, 845 N. 18th Street, stated that the city had a chief that they brought in from the outside at one time in the past and we made him sign a contract with us. Other departments do this in every department so we don't have rotating chief. Have we considered having a contract with the chief that would obligate him for a certain amount of time with a penalty involved.

Mr. Julio Guridy thanked Mr. Houck and stated certainly some of them have talked about something like that. It could certainly something that could be considered in the future.

Mayor Ray O'Connell stated that Assistant Chief Lake is here to explain the contract with the school district and Council's approval.

Assistant Chief Lake thanked the Mayor and Council and stated that this proposed contract with All City Management for crossing guards services for school children going from home to school then back again at the end of the day. As you know, we did staff crossing guards this past spring. This particular vendor did provide some of the services as well. We also used this vendor. The city used this vendor over the past year.

Mr. Julio Guridy asked if there were any comments from the dais.

Mr. Ed Zucal asked if the school district contributing to any of this cost. Do we have a guarantee from the Crossing Guard Company that they are going to supply the people. As you know, over the years we had to take officers off the street to do crossing guard duties.

Mayor Ray O'Connell stated that they have been, but the administration feels that they have not given a large enough percentage to off balance the cost of the crossing guards. Our legal team and the administration will be meeting with their administration and their legal team. We do have a recommendation from the legal department with other third class cities do. We will pursue that and this year we will pursue it hard. It is a big amount of money.

Assistant Chief Lake stated that the city has worked with this vendor in the past. Most recently in the spring, when ASD went back to "normal" schooling for about seven weeks and they did an excellent job. They found people overnight. Once we learned ASD was going back that left them in a position that we had to scramble and a local agency had to assist. He had to cross children and the police had to command the post.

Mayor Ray O'Connell stated that their fill rate is really good. We scrambled at the last minute and got them all there and we did go to an outside agency to fill the gaps. Some community members stepped up with their organizations and it worked out well. We were really proactive.

Ms. Ce Ce Gerlach stated along those lines we all know that right now

employers are increasing its wages. Do we know if this employer has increased its wages so that we can remain competitive for the folks that are paying \$22 per hour. She stated to ensure that the fill rate can be done.

Assistant Chief Lake stated that he does not know what they pay. He stated that is a great question and a fair question. He can't comment on what this agency pays their employees. They were the lowest bidder. When the bids first came back, one was over \$1 million. He stated that he thinks this is very fair.

Ms. Ce Ce Gerlach asked about entering the meeting with ASD. Crossing Guards not only cross the kids/students, they cross the citizens as well. How do you balance that? Is that in their contracts?

Assistant Chief Lake stated that is a crossing guard being kind. From a crossing guard perspective when he filled in at Sixth and Linden other people came by and he crossed them. This is designed to cross school children.

Ms. Ce Ce Gerlach stated that she feels it is very competitive for a couple of hours and crossing kids, but no she is not sure. It may not be competitive anymore which means they will have a harder time filling.

Assistant Chief Lake stated that he does not know what their hourly rate is, but in the spring he was told that they were paid not only for the two hours they were there, but a third hour to sweeten the pot.

Mr. Daryl Hendricks stated that the city has not used them only for a brief period in the spring. They are out in California.

Assistant Chief Lake stated that the city used them this past spring, but we had also used them previously over the last several years. He stated that is where the company is based in with local representatives. Using this past spring as an example, once we had contact with the company in California they reached out to their local representative here who found people overnight. He was amazed. He did not think they would get enough crossing guards to do what we needed them to do. They did a good job.

Mr. Jeffrey Glazier stated that he has a Weekly Payables Report covers the period from the 4th of July through the 30th of July. It is hot off the press. It was just released today. Highlights: reviewed 431 checks for smidge under \$6 million, reviewed 21 manual \$350,000 and there were no wires posted in this period. There were notable findings: incorrect invoice entry, lack of budget transfer approval,

invoices paid for the incorrect amounts, 24 invoices were paid after 60 days.

Mr. Julio Guridy stated that it was a very condensed report. Thank you very much. What do we do? Do we just let that go on the \$27,000 transfer? Do they bring it back to Council.

Mr. Jeffrey Glazier stated that is a fair question. It could be a discussion with the department head or the legal department.

Mayor Ray O'Connell stated Mr. Glazier does a fine job. Corrective action has taken place. His recommendations are find and we abide by his recommendations.

Mr. Julio Guridy stated it just does not look good. To make it clean, bring it back and that way we can move forward.

Mayor Ray O'Connell stated that the administration will bring it back.

Mr. Julio Guridy stated to the Mayor you may have talked to Mr. Siegel, but he did not know about it.

Mayor Ray O'Connell stated that it will be taken care of.

Mr. Daryl Hendricks stated that it was forwarded favorably 3 - 0.

Mr. Julio Guridy asked if there were any further comments from the dais or the public.

Ms. Angelyn Washington (sp), 713 N. Nelson Street, stated that making it eight adult over youth seems that they are overshadowing them. Putting more of the other people instead of them it does not help showing you how we are. It is belittling them. It is the youth that is dealing with the violence in the schools and in our families.

Mr. Julio Guridy stated thank you for coming over and speaking. They certainly discussed that and will take it into consideration. The idea is hopefully they get enough youth to come over to join the Council and hopefully they can reverse that. It is something that they discussed very seriously during the preparation.

Mayor Ray O'Connell stated that he is hearing her say there should be more youth instead of adults. Are going to make that commitment?

Mr. Julio Guridy stated no. At this time we are going to move forward and

as we move forward and get more youths. Hopefully, there will be more meetings soon. When the chair sets the meeting, he would suggest that they look into that as well.

Ms. Ce Ce Gerlach stated that for the adults members that are currently on the Youth Commission. How long is their terms? She asked if they could make the adults one year terms since that is the intent is to eventually decrease the amount of the adults and increase the amount of youth. Could we make the adult positions a one year term.

Mr. Julio Guridy stated that there are staggering terms. He stated that he would rather go what they have right now. It is a good suggestion. We can have the Board change the bylaws. Today's Resolution is to increase the amount of people on the board.

Ms. Ce Ce Gerlach stated that she played zero role in forming this Commission. Would it be possible to wait a little minute until some more youth are on the Commission? Right now, this decision to make the Commission more adult, has been made by adults.

Mr. Julio Guridy stated that he rather not. They have been trying to get this board formed. It is on the Agenda today. He does not want to keep holding it.

Mayor Ray O'Connell stated that they are appointed by him. Anyone on Councilperson or any public person can nominated. All five are not one year and goodbye. They are rotating.

Mr. Julio Guridy stated that is what he said. They are staggering terms.

Ms. Ce Ce Gerlach stated that can be a concern if the youth are showing up and active and involved. Meantime, we have an adult with a three year term. Can we delay until after the board meeting and then we as a Council can vote on it. You formed a Youth Commission and it kind of went away.

Mr. Julio Guridy stated that the problem is that we have been waiting and waiting and waiting. He stated that he knows where she is going, but he thinks that they should approve the three adults and have the board suggestions.

Mr. Joshua Siegel agreed with Ms. Gerlach. It feels like they are opposing the decision on the Council of Youth. He is hearing a lot of I, I, I and We, We, We and Me, Me, Me. The reality is this is a body that supposed to be a voice for this city. The most apropos thing to do is table this until we can fill the body with at least six youth. Let them work together with the five

adults that are already there. If they come to the conclusion that they think they want more adults representatives there, it should be their decision. We are not sending a good example of youth we are trying to empower.

Mr. Julio Guridy stated that they have been working on this for several years now. Some people in Council feels that it is wrong. There are people that worked really hard to put together this board and people were invited. Everybody was invited on Council and the public and they did not come.

Mayor Ray O'Connell asked how many meetings had been held in a formal discussion.

Mr. Julio Guridy stated that there were five or six meetings were held they had a meeting for the initial board which were only five people. We were trying to get people involved on this Council. He submitted several names. Let's move forward and we can always change anything.

Mr. Julio Guridy stated that he appreciates if he stops making eyes and making motion to the Mayor and other people when he is speaking. Thank you very much.

Mayor Ray O'Connell asked who is making eyes at me.

Mr. Julio Guridy stated that he saw him and he saw Mr. Siegel and it is very disrespectful. He stated to Mayor O'Connell, please respect me as he respects him.

Mr. Michael Hanlon stated that there will be a presentation at Ms. Gerlach's Committee meeting.

Ms. Ce Ce Gerlach stated thank you.

Mr. Julio Guridy asked if there were any comments from the dais or the public.

Ms. Ce Ce Gerlach stated that they had the last Council meeting and that was a bit interesting. It is really important as Councilmembers we have a certain level of decorum that we are not chastising members of the public or gas lighting them. That we are not doing that to one another, publicly. If we have an issue with one another, some of us had issues with me, but you have taken them up with me. You told me how you feel about me and stated that she has listened. We agree to disagree and we won't go to each others cookouts and that's ok. We sit up here and work with one another. It is really important that as we want respect from the public, that we amongst ourselves also continue to respect each other as colleagues on Council because when the public sees us disrespecting each other, it makes it a little easier for them to come up and also and maybe throw some dabs at some of us. She stated that if anybody has issues with her and she is looking at the wrong person, please call her and they can work that out.

Mr. Julio Guridy asked if that is something that has to do with R124.

Ms. Ce Ce Gerlach stated that she skipped ahead. She stated that she is very passionate.

Ms. Ce Ce Gerlach stated that was her New Business. That was her comment.

Mr. Ed Zucal stated that he received a phone call yesterday as well as a copy of a letter from an employee that retired from the city of Allentown with 40 years of service with no blemishes on his record. He has been paying and retired three years and he has been paying a bi-weekly payment taken out by the insurance company. He received a letter on Monday stating that as of July 31, he no longer has coverage for him or his family. The letter went on to say that he has not paid his premium for 18 months which now he owes approximately \$18,000. Luckily, he has been saving that money and he has got the money to pay it. He stated that is a concern to him that the insurance company and this city can manage to allow or foresee that someone has not paid their insurance for 18 months and yet they had the coverage for 18 months up until the end of July. If this poor guy did not have the \$18,000 to pay we would be screwed. His wife has some medical issues and stated that he knows he has some medical issues. This is unforgivable. Discipline should be handing out to somebody.

Mayor Ray O'Connell stated let's look at the facts.

Mr. Ed Zucal stated that he will see that the person calls him and gives him the facts.

Mayor Ray O'Connell stated absolutely. Retired how long ago.

Mr. Ed Zucal stated that he thinks he has retired two or three years from the Comm. Center with 40 years of service with the city.

Mayor Ray O'Connell stated that he wishes that he would have heard it before the meeting which would have been common courtesy.

Mr. Ed Zucal stated that the person states that he made attempts to contact HR with no success.

Mayor Ray O'Connell stated that he is not bragging, but the buck stops with him and the Controller. He asked Mr. Glazier has he called him.

Mr. Jeffrey Glazier stated that he has not called him.

Mayor Ray O'Connell stated that there was a similar instance with this with some tax issues. He stated to Mr. Zucal that his phone and door are

always open and would have loved to heard it from him because HR or any department he is in charge of the departments and in charge with the cabinets and all directors.

Mr. Ed Zucal stated that the constituents come to Councilmembers.

Mayor Ray O'Connell stated that it almost feels like you are trying to embarrass me.

Mr. Ed Zucal stated that the embarrassment from your own department.

Mayor Ray O'Connell stated that if it is true.

Mr. Ed Zucal stated that it is true. He got the letter.

Mayor Ray O'Connell stated ok, he will check the letter. It would have been a nice heads up phone call from him. Did he try to contact me?

Mr. Ed Zucal stated that he does not know that.

Mr. Jeffrey Glazier stated that the Controller's office looked over Account Receivables over \$10,000 and broke those invoices down into a number of categories. One had to do with the Police Department. That audit will be released tomorrow. Some of the accounts over \$10,000 have to do with liens on properties whether it be for sidewalks or demolition. He stated that the Controller's office is working with those departments on those audits. They will be released sometime in the future. The last part of the audit had to do with retiree medical and there were a couple of accounts over \$10,00 where people owed. We had met with HR on this and Finance on the Audit Report and have a number of days to respond to this before we put it out to the public. The Personnel Code which we live and die states that you have to pay by the 8th of the month or your benefits are terminated. He can't to them what led to a person not paying for 18 months. He will certainly reserve his judgment and comments until a later time. We look at the Account Receivable Reports and go from there. We are also looking at Accounts Receivable under \$10,000. That Report will come out in some time in the future.

Mr. Ed Zucal stated that when this meeting is over, he will have the gentleman call the Mayor.

Mayor Ray O'Connell stated thank you.

Ms. Candida Affa stated that she agrees with Mr. Zucal that they come to Council. They come to Council. They call and email us. She does agree

and is sure the other colleagues do is will go through the source: The Controller, the Public Works Director or the Police Department. Our job is not to put it out there. She will do this and a lot of her colleagues will go to the source. It is not necessary to come up here on Council and want solutions without going to the departments for the solutions. Tonight has been a really like a weird circus. A lot of things are being said and a lot of hotheads. We need to calm down and as Council people we can do our job without bringing it here every Council meeting. We can go directly to and now we have a Solicitor too. We have to watch our behaviors sometimes. She agreed with Ms. Gerlach on that.

Mr. Julio Guridy stated that we have to respect each other and that is what Ms. Gerlach said. If we have a decorum on respecting each other, we should be ok.

Ms. Cynthia Mota stated that she agrees with Ms. Gerlach and Ms. Affa. The reality is that the culture has to change. It is a lack of respect. You go to the source. You tell them what is going on, but the reality is when you go to those people, they embarrass you in front of everyone and in front of the media. And, God forbid if you say something out of character. You can get sued. The lack of respect has to stop. It is a lack of caring going on. There was an incident that happened. As you know, two days ago it was a murder, a 27 year old man was murdered on the east side. She stated that she called Chief Roca and he was great. She stated that he called her back and the reason why she called him is because she went to the scene with Promise Neighborhoods and saw there was a pile of blood. We took Clorox and tried to clean it. The reality is that it has to do with the quality of life. The lady that held the victim in her arms it was very traumatizing and seeing the blood there a day later is very traumatizing. Chief Roca called the Fire Department and they came and when they came, they saw us cleaning, but we were using a hose that was not strong enough so the blood was still there. They really didn't acknowledge us,. They just drove away. Chief Agosto was also wonderful. He apologized and said that he will send them back. They came back and one of the firefighters treated me so poorly and yelled at her that is not to clean the blood there. She called Chief Agosto and he fixed the situation. We have to fix the culture. We have to be in the same cage. When there is an accident, who cleans it. How long it takes to clean it and do you clean it the right way. Imagine that woman what she was going through, traumatized. Holding that person in her arms. And, that man took his last breath. She has to witness the blood everyday. Come on. You have to be inhumane not to do something about it.

Ms. Ce Ce Gerlach stated that was her New Business. That was her comment.

Ms. Sherea Wiles, 304 N. 8th Street, stated that one of the things they should do is try to get the requirements for felons to be able to come back into the homes for HUD housing. They are not able to apply for HUD Housing and Section 8. We have to take that requirement off.

GOOD AND WELFARE

Mr. Daryl Hendricks commended the Fire Department for two weeks ago the fire that occurred at one of our schools at Union Terrace at a very hot day. One of the firefighters were overcome with the smoke and ended up in the hospital. He commended them and said it is important because they did a great job that day and probably saved the school building. We lost some mobile homes outside the building.

Mr. Julio Guridy thanked Mr. Hendricks and stated that he thinks that the majority of the city's staff and the administration do a wonderful job. Nobody is perfect. The majority of the staff in the city does a great job and works hard and really care. There maybe one or two that sometimes you encounter everywhere. He does not want people in the city are misbehaving and doing the wrong thing. The majority of them do a wonderful job. Thank you for all you do and let's keep working.
