AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a transfer of Twenty-One Thousand Six Hundred and Seventy-Four Dollars and Forty-Six Cents (\$21,674.46) from the unappropriated balance in the Golf Funds to the Golf Capital Projects fund. These funds will be used for outstanding capital improvements from last year to enhance the golf course.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That the City Council authorizes a transfer in the amount of Twenty-One Thousand Six Hundred and Seventy-Four Dollars and Forty-Six Cents (\$21,674.46) to the following account:

SECTION TWO: That this Ordinance takes effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
