Authorizes Submission of a Formal Application to the Pennsylvania Department of Transportation for a Grant of Nine Hundred Ninety-Two Thousand Nine Hundred Sixty Dollars (\$992,960.00) to support the Downtown Signals Project at Lehigh and Union Streets.

Resolved by the Council of the City of Allentown, That

BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a Multimodal Transportation Fund Grant of \$992,960.00 from the Pennsylvania Department of Transportation to support roadway widening and installation of a new traffic signal at the intersection of Lehigh and Union Streets.

BE IT FURTHER RESOLVED, that the City of Allentown hereby designates Ray O'Connell, Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Allentown, hereby authorizes the City of Allentown to submit the application for Nine Hundred Ninety-Two Thousand Nine Hundred Sixty Dollars (\$992,960.00) in Multimodal Transportation Funds to the Pennsylvania Department of Transportation.
