Introduced by the Administration on February 2, 2022

Authorizes Acceptance by the City of Allentown for Maintenance of the Lighting System on the Tilghman Street Bridge from Pennsylvania Department of Transportation

Resolved by the Council of the City of Allentown, That the City of Allentown is desirous of entering into an agreement with the Commonwealth of Pennsylvania, Department of Transportation for the purpose of maintaining the lighting system on the Tilghman Street Bridge.

WHEREAS, the Pennsylvania Department of Transportation (PennDOT) is rehabilitating the Tilghman Street Bridge in the City of Allentown which is part of SR 1002-04B.

WHEREAS, part of this three year long project includes the installation of a new lighting system on the bridge.


WHEREAS, PennDOT, is requesting the City of Allentown assume ownership, custody and control of the maintenance of the lighting system upon completion of the project.

NOW THEREFORE BE IT RESOLVED that the Legislative Body of this Municipality enters into and agrees to the Conditions of Transfer including operation and maintenance, specifications and approval, PennDOT repairs, third party contracts, and prohibited use; all of which are defined in the attached PennDOT Agreement number 057462.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Council of the City of Allentown hereby approves of the submission to the Commonwealth of Pennsylvania, Department of Transportation, the agreement to accept responsibility for the lighting system subject to the terms and conditions in the attached PennDOT Agreement number 057462.
