Authorization for Contract with TD Equipment Finance for \$2,223,332.54 to finance Ten (10) Mobile Radios Model XG-25M, Fifty (50) Mobile Radios Model XL-18M, Ten (10) Portable Radios Model XL-95P, Fifty (50) Portable Radios Model XL-200P (Yellow), Three Hundred and Fifty Five (355) Portable Radios Model XL-200P(Black), Radio Accessories Metal Belt Clips, "D" Clips and Antennas, Radio Batteries and Radio Battery Chargers, there were four proposals, the lease is for five years.
