Approves the submission of the formal application for the local share account grant on behalf of Lehigh Valley P4P Boxing, Inc. to fund facility repairs to assist in the continuation and operation of their successful youth enrichment boxing program.

Resolved by the Council of the City of Allentown, That

WHEREAS, the City of Allentown is desirous of submitting a formal application to the Pennsylvania Department of Community & Economic Development for a grant of fifty thousand dollars (\$50,000.00).

NOW, THEREFORE, BE IT RESOLVED, that the City of Allentown, Lehigh County hereby requests a local share account grant on behalf of Lehigh Valley P4P Boxing, Inc. to fund facility repairs to assist in the continuation and operation of their successful youth enrichment boxing program.

BE IT FURTHER RESOLVED; that the City of Allentown hereby designates Matthew Tuerk Mayor, and Seth O'Neill, Finance Director, as the official(s) to execute all documents and agreements between the City of Allentown and the Commonwealth.
