AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a supplemental appropriation of Three Hundred Ninety-Eight Thousand Six Hundred (\$398,600) Dollars from the Pennsylvania Department of Conservation and Natural Resources (DCNR) to support construction phase 2 of Jordan Skatepark.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2020 Capital Fund in the amount of Three Hundred Ninety-Eight Thousand Six Hundred (\$398,600.00) Dollars from the Pennsylvania Department of Conservation and Natural Resources. Dollars as follows:
