### Overview / Presentation of RFPs for Disposal and Collection

- WM contract ends May 31, 2025. New contract begins Sunday, June 1, 2025
- Hired Consultant, Allison Trulock, NewGen Strategies & Solutions
- 2024 Citizen survey trash and recycling results
  - o 1,342 responses
  - o 52% say they place out 2 or less trash bags each collection night
  - o 87% say they place out 1-2 recycling bins each week
  - o Out of Quality Service, Consistent Collections, and Cost, cost was rank the lowest
  - o 61% stated they wanted to continue with twice a week trash collection.
  - 28% stated they would want to switch to once a week, only if there was a cost savings
  - 87% wanted to continue with overnight collection
  - 62% support a requirement that all trash must be bagged and placed in a trash can to reduce litter.

The different collection options in the RFP were based on the responses and through discussion with our consultant.

# **DISPOSAL**: Council has already approved this contract and will begin June 1, 2025

**Disposal Contract Awarded to Bethlehem Landfill Company** 

- Estimated Total 2025 Cost per ton = \$72.07 for Contract Year 1
- Waste Management Current Rate = \$64.03
- Bethlehem is a 13% increase over current rate.

- 1. Solid Waste Services, d/b/a J.P. Mascaro & Sons
- 2. Waste Management of PA

# Based on the Technical and Cost Proposals and Oral Presentations, the Evaluation Committee is recommending awarding the contract to <u>J.P. Mascaro & Sons</u>

- The Evaluation Committee has decided to select Scenario A Status Quo, Manual Collection with 2 times per week trash collection with once a week recycling collection.
- **JP Mascaro's total cost** for Contract Year 1 = \$16,320,165. (Based off 37,169 units in collection)
- Waste Management's proposed cost for Contract Year 1 = \$26,587,060. (Based off 37,169 units in collection)

#### **BUDGETING:**

- **2024:** Budgeted \$10,326,248 for Disposal & Collection under Waste Management's current contract.
- **2025:** Budgeted for 5 remaining months of Waste Management's current Contract and 7 months under the new contracts. **For a total cost of \$15,692,013.**

• Trash Fee Increase for 2025 & 2026 -Based on actual costs. As discussed in last years budget discussions surrounding the trash fee, it was anticipated to be a 65% increase.

The increase in the Solid Waste fee from \$415 to \$605 is the minimum we can implement without risking a deficit. This represents an additional \$50.41 per month, or \$1.65 per day, in 2025.
