AN ORDINANCE

Amending the 2025 General Fund budget to accommodate the upgrading, retitling, and addition of positions in the Departments of Law, Finance, City Council, Police and Public Works.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That page 85 of the General Fund budget be amended by deleting the position of Office Manager (09M) with the total salary budgeted in the amount of Sixty-Eight Thousand Eight Hundred and Ninety-Six (\$68,896) Dollars; and adding the position of PW Operations Supervisor (11S) with a salary budget of Seventy Thousand and Nine (\$72,520) Dollars.

SECTION TWO: That City Council allows for a transfer of One Thousand Seven Hundred Fifty-Six Dollars (\$1,756) in the following manner:

Upgrading and retitling the position of Contract Paralegal (s11) with the total salary budgeted in the amount of Seventy-One Thousand Six Hundred Ninety-Eight Dollars (\$71,698) to Senior Paralegal (Contracts) (s15) with a total salary budgeted in the amount of Eighty-Two Thousand Three Hundred Two Dollars (\$82,302).

Upgrading and retitling the position of Legal Office Administrator (s11) with the total salary budgeted in the amount of Seventy-Four Thousand Two Hundred Fourteen Dollars (\$74,214) to Senior Paralegal (Office Administration) (s15) with a total salary budgeted in the amount of Eighty-Two Thousand Three Hundred Two Dollars (\$82,302).

Upgrading and retitling the position of Assistant City Solicitor (s18) with the total salary budgeted in the amount of One Hundred Thirteen Thousand Nine Hundred Six Dollars (\$113,906) to Assistant Solicitor (s20) with a total salary budgeted in the amount of One Hundred Sixteen Thousand Three Hundred Twenty-Five Dollars (\$116,325).

Upgrading the position of Deputy Solicitor (s20) with the total salary budgeted in the amount of One Hundred Eleven Thousand Four Hundred Sixty-Two Dollars (\$111,462) to Assistant Solicitor (s21) with a total salary budgeted in the amount of One Hundred Thirteen Thousand Eight Hundred Fifty-Two Dollars (\$113,852).

Upgrading and retitling the position of Right-to-Know Officer (s9) with the total salary budgeted in the amount of Sixty-Four Thousand Fifty-One Dollars (\$64,051) to Paralegal (Right-to-Know-Officer) (s11) with a total salary budgeted in the amount of Sixty-Eight Thousand Nine Hundred Eighty-Seven Dollars (\$68,987).

SECTION NINE: That page 67 of the General Fund budget be amended by changing the positions: of Contracts Administrator (S10), with the budgeted salary of \$69,970, to Procurement Sourcing Specialist at the paygrade (S12) with the salary of \$73,978; Purchasing Coordinator (S7), with the budgeted salary of \$64,446, to Procurement Sourcing Specialist at the paygrade (S12) with the salary of \$72,109; Buyer (S10), with the budgeted salary of \$73,298, to Procurement Sourcing Specialist at the paygrade (S12) with the salary of \$77,715; and another Buyer (S10), with the budgeted salary of \$71,634, to Procurement Sourcing Specialist at the paygrade (S12) with the salary of \$75,846.

SECTION TEN: That page 63 of the General Fund budget be amended by changing the positions: of Treasury & Accounting Coordinator (S06), with the budgeted salary of \$58,902, to Payroll & Treasury Coordinator at the paygrade (S11) with the salary of \$68,987; Accountant (S13), with the budgeted salary of \$93,080, to Senior Accountant at the paygrade (S15) with the salary of \$99,712; and another Accountant (S13), with the budgeted salary of \$93,080, to Senior Accountant at the paygrade (S15) with the salary of \$99,712.

SECTION ELEVEN: That page 351 of the Risk Fund budget be amended by upgrading the position of Benefits Coordinator (S10), with the budgeted salary of \$73,938, to the paygrade (S11) with the salary of \$79,589.
