On January 7, 2022, the City advertised a solicitation in order to obtain a Contractor(s) to furnish and/or deliver and/or apply road materials, including but not limited to geotextiles, for the City of Allentown. Quantities are estimated based on 2021's usage and shall be purchased at the unit prices identified in the bid tabulation. The City has allocated funds in the Budget to cover the costs of the materials. Based on estimated quantities provided before the advertisement of the solicitation, the annual estimated budgeted amount for the road materials is \$1,851,547.00. The quantities provided in the bid are estimates, and as such, the actual cost of the materials may vary throughout the year based on the needs of the department. The City held a public opening on February 4, 2022, and the City received seven (7) bids. All bids were reviewed and at this time are recommending award to five (5) Vendors, as noted herein.

## Contract Term:

The Contract term shall commence on April 1, 2022 and shall cease on March 31, 2023. Upon written notification, this contract can be extended for up to an additional three (3) months beyond the contract expiration period.
