AN ORDINANCE

Amending the 2023 General Fund Budget to provide for a supplemental appropriation of Thirty-Seven Thousand Seven Hundred and Eighty-Three Dollars (\$ 37,783.00) from the Commonwealth of Pennsylvania, Department of Community and Economic Development Local Share Account grant for the purchase of a vehicle for Lehigh Valley P4P Boxing.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes a supplemental appropriation of Thirty-Seven Thousand Seven Hundred and Eighty-Three Dollars (\$37,783.00) to the following account:

Community and Economic Development on behalf of Lehigh Valley P4P Boxing

- Summary and facts of the bill.

The purpose of this ordinance is to appropriate the revenue and expenses for the Commonwealth of Pennsylvania, Department of Community and Economic Development Local Share Account grant for the purchase of a vehicle for Lehigh Valley P4P Boxing. Lehigh Valley P4P Boxing was awarded \$37,783.00 to support the purchase of a vehicle to transport the youth to competitions and sparring sessions.

 - a. What does the bill do? What are the specific goals or tasks the bill seeks to accomplish?

The Bill will provide funding toward the purchase of a 3-row van to transport the team to competitions and sparring sessions. Currently the coach, with the assistance of volunteers, transports the team. When sufficient volunteers are not available to assist with transportation needs, members of the team are not able to attend the event.

The bill appropriates the grant funds, which will support Lehigh Valley P4P Boxing with the purchase of a 3-row van.

- b. What are the benefits of doing this?

The purchase of a 3-row van will provide a multitude of benefits to the youth attending Lehigh Valley P4P Boxing. Purchasing transportation will allow Lehigh Valley P4P to expand its attendance in community events, competition, and sparring sessions. It will ensure that all team members are able to attend all competitions, thus, showcasing their talents. Overall, the purchase of a 3-row van will provide enriching experiences to a larger number of local youth.

- c. How does this bill relate to the City's vision/mission/priorities?

This Bill relates to the City's vision and mission as Lehigh Valley P4P Boxing provides a safe, enriching environment for the youth of Allentown. Thus, providing a safer City for all who live, work, and visit the City of Allentown.

There is no cost to the City, as Lehigh Valley P4P will incur all expenses not covered by the \$37,783 awarded in grant funding.

This appropriation will benefit the youth of Allentown by giving them a safe environment to showcase their talents. Additionally, this appropriation will reimburse Lehigh Valley P4P Boxing for the expenses related to the purchase of this vehicle.
