• Description of project or scope of services to be provided and why is an increase needed:

The purpose of this change order is to add \$99,990.46 to the contract sum. This is to pay for the time required to be on site with the construction team for the duration of the project that was completed on November 2, 2022 per PennDOT's contract requirements. Due to this requirement, more time has been spent on site and needs to be applied to the contract for oversight of the construction. This increase is needed because the original amount was based off what PennDOT bid out, they estimated the time needed but it was exceeded. This increase in sum is dictated by PennDOT due to the grant the City received from them.

The term expired November 8, 2022. We are not extending the term only increasing the sum to pay for the completion of the project.
