AN ORDINANCE

Amending the 2023 General Fund Budget to provide for a supplemental appropriation of Four Thousand Nine Hundred Fifty (\$4,950.00) Dollars from DLNHC (Delaware Lehigh National Heritage Corridor) as part of their Trail Amenity Grant for expenses made to enhance the D&L Trail in Canal Park.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2023 General Fund in the amount of Four Thousand Nine Hundred Fifty (\$4,950.00) Dollars reflecting receipt of monies from the DLNHC:

SECTION TWO: That City Council authorizes a supplemental appropriation from the unappropriated balance of the General Fund as follows:

SECTION THREE: That pursuant to SECTION 218 of the Home Rule Charter and upon the affirmative vote of six of seven members the fourteen-day period between introduction and passage is hereby waived.

SECTION FOUR: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.
