AN ORDINANCE

Amending the 2021 Capital Fund Budget to provide for a supplemental appropriation of Four Hundred Eighty-Six Thousand Two Hundred Seventy-Three (\$486,273) Dollars from the Pennsylvania Department of Transportation TASA funds for the construction of the Jordan Creek Greenway Trail.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2021 Capital Fund in the amount of Four Hundred Eighty-Six Thousand Two Hundred Seventy-Three (\$486,273) Dollars reflecting receipt of monies from PennDOT TASA:
