6: Status Updates from leads on goals

- 1. Neighborhood Cleanup Initiative (Tinku)
 - a. Sacred heart blueprint community initiative has "thrown a wrench" into the plan. It is on hold currently.
- 2. Shared energy manager (Tinku)
 - a. We got this funding and Wilson engineering has been a
 great help for the EV pilot program. We have also
 submitted applications for AFIG and EECBG grants.

 Grant amount will be a percentage of the vehicle and
 infrastructure costs, so it will depend on specific vehicles
 and infrastructure. Mayor's new EV vehicle is included.
- 3. Warehouse initiative
 - a. ZONE Allentown comments were officially submitted. Molly wrote a great article on that. EAC should send out the schedule for ZONE allentown events such as the upcoming one at civic theater.
