This serves as notice that Allentown City Council has introduced Bill 99 on October 6, 2021 - to approve, adopt and enact an Ordinance Codification for the City of Allentown; to provide for the repeal of certain legislation not included therein; to save from repeal certain other legislation not included therein; and to provide penalties for tampering with the Code. The Codification is the complete body of legislation for the City of Allentown.

City Council plans to adopt Bill 99 at its regularly scheduled Council Meeting on December 1, 2021, at 6:30 pm. The meeting will take place in Council Chambers, 435 Hamilton Street, Allentown, PA. If approved, the new Code shall go into effect January 1, 2022.
