AN ORDINANCE

Amending Article VIII, Allentown Parking Authority, by removing the requirement that a member of the Parking Authority must also be a representative of the AEDC, allowing the Mayor to designate and Council to approve any resident of the City of Allentown.

SECTION ONE: That Article VIII, Allentown Parking Authority be amended to read as follows:

Article VIII

Allentown Parking Authority

[Adopted 10-17-1984 by Ord. No. 12628 (Article 168 of the 1962 Codified Ordinances)]

§ 12-41 Membership

Prior to the incorporation, the Mayor of the City of Allentown shall appoint five members, all of whom shall be residents of the City, who shall serve on the Board of the Parking Authority of the City of Allentown. The members who are first appointed shall serve for terms of one, two, three, four and five years, respectively. Thereafter, the term of office shall be five years. The members of the Board shall include a member of the Council of the City of Allentown, **and** the Director of Finance or **his their** designee ~~and a representative of the Allentown Economic Development Corporation~~. The position of any member of the Board appointed because of his capacity as Councilperson, Director of Finance or **their** his designee or Allentown Economic Development Corporation representative who ceases to be so engaged shall automatically be considered vacant. The member of the Council of the City of Allentown and the Director of Finance or his designee shall not serve as the Chairperson of the Allentown Parking Authority.

SECTION TWO: That this Ordinance will take effect ten (10) days after final passage.

SECTION THREE: That all Ordinances inconsistent with the above provisions are repealed to the extent of their inconsistency.

The amendment removes the requirement that a member of the Parking Authority must also be a representative of the AEDC.

The amendment allows the Mayor to designate and Council to approve any City resident.

It expands the candidacy pool of those who can fill a vacancy on the Board. Not only is this seat currently set aside for an AEDC representative, that person must also live in the City.

The change allows any city resident to participate civically if they choose to/are selected to serve on this board – regardless of affiliation with any organization.

Currently there is a vacancy that exists on the APA Board. The AEDC representative that was holding the APA Board seat is no longer serving as an AEDC representative.

This change will allow the Mayor to designate any city resident, regardless of their affiliation with the AEDC, to the APA Board. This opens up the pool of candidates that can be considered.
