AN ORDINANCE

Amending the 2025 Capital Fund Budget to provide for a supplemental appropriation of Three Hundred Thousand (\$300,000) Dollars from the Pennsylvania Department of Conservation and Natural Resources (DCNR) to support construction of MLK Trail Phase 2.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the 2025 Capital Fund State Aid revenue account in the amount of Three Hundred Thousand (\$300,000.00) Dollars from the Pennsylvania Department of Conservation and Natural Resources as follows:
