AN ORDINANCE

Amending the 2023 Capital Fund Budget to provide for a supplemental appropriation of Six Hundred Fifty Thousand (\$650,000) Dollars from the Pennsylvania Department of Conservation and Natural Resources (DCNR) to support design and construction of the D&L Trail – Allentown Segment.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ALLENTOWN:

SECTION ONE: That City Council authorizes an increase to the unappropriated balance of the 2023 Capital Fund in the amount of Six Hundred Fifty Thousand (\$650,000.00) Dollars from the Pennsylvania Department of Conservation and Natural Resources. Dollars as follows:

- What department or bureau is this bill originating from? Where did the initiative for the bill originate?

Parks and Recreation

- Summary and facts of the bill.

Purpose of the ordinance is to appropriate the revenue and expenses for the Department of Conservation and Natural Resources (DCNR) grant for design and construction of the D&L Trail – Allentown Segment from Bradford St to the city line on Dauphin Street. City received a \$650,000 grant to support this design and construction phases.

The Bill appropriates the grant funds, which will support the creation of the D&L Trail in continuation to the existing trail.

- b. What are the benefits of doing this? What are the drawbacks?

The City is receiving \$614,417 in matching funds from DLNHC from their DCED grant (MOU is in process) they received, and the City has committed \$50,000 in matching funds from the Trexler fund (TTFY 2024-2025).

The funding comes from the Pennsylvania Department of Conservation and Natural Resources.

This is a high priority project.

Approving this allocation of funds will allow the Department to design and construct the D&L Trail from the existing trail on Bradford Street all the way to the city line on Dauphin Street. This will connect the community to Hanover Township to complete the link of the D&L Trail.
